# **Constitution Rule 11. Annual/Special General Meetings (4) (b)** to receive from the committee reports upon the transactions of the Association during the last financial year;

a) Treasurer Mick Lubawski advised there was an opening balance of \$15,926.94, some of the income that came in over the year was from match fees and that was \$10,964, the income from the Summer Competition was \$6,500, so the total income for the year was \$28,750. Regarding expenditure, the cost of the Annual Presentation Ball \$8,146.90, the expenses for the Summer Competition was \$5,768.85, the total expenditure came to \$26,277.92. This gave the league a profit overall for the year of \$2,472.25 (see below for detailed Treasurer's Report.

Treasurer Mick Lubawski informed the sponsorship we got for this year was \$3,500 so we should put our hands together to show our appreciation for the Publicity Officer Rick Merlo, everyone clapped.

- **b)** President Andrew O'Neill stated that at the previous AGM the league's bookkeeping was discussed due some discrepancies in the accounting due to a lack of details kept in the past. Andrew O'Neill has worked with Treasurer Mick Lubawski in this past year to improve the record keeping ensuring the league documents clearly the money coming in and out and for what purpose. Andrew assured everyone there has been no money missing, the issue is around documenting how we record income and expenses. Andrew O'Neill stated we have discussed having the account audited but we don't really need to do that, we just needed to look at how we do things and keeping an accurate running sheet. President Andrew O'Neill asked for the Treasurer's Report to be moved if there are no other questions.
- c) Just a little bit more as I should mention about the Annual Presentation Ball and as Mick Lubawski stated there was an \$8,000 bill there, just over in fact, but when you break it all down with the deposits and all that it actually cost us \$4,500 as compared with the previous year's cost of \$3,300 though they only had 130 there where as we had 163 there last year. I did the math's and took of 33 to bring it back to 130 and did the math's again and worked out it to be \$52 difference. By having those deposits it brings it right back so we can put on a really good function like last year, it cost more but that \$15

deposit really did reduce the of overall cost and makes it a cost effective event. We have had issues over the years with the cost of these events, where we have not had enough sponsorship coming in and also with the Annual Presentation Ball raffle, deposits ect we have had a couple of really big deficits, we weren't doing what we needed to do to offset those really big bills. The last two years we have had \$2,500 profit which is more than enough we don't really need to have that much but that's ok.

**d)** Gary Helmuth (Snaz) (Top Pub Elites) asked about sponsorship and how important it is and that everyone should know someone who can help out in the way of sponsorship. President Andrew O'Neill explained that we had a sponsorship income of \$3100 and an income of \$22,981 and an expenditure of 20,500, we are dealing with a lot more money now but that's because the league is so much bigger. If you take off that sponsorship from the profit (\$2,500) we would actually have a deficit instead of a profit! So sponsorship is really important for us so get out and support them.

# **Pool Victoria Report:**

 Pool Victoria Delegates Report. President Andrew O'Neill stated he attended the Pool Victoria Annual General Meeting held on 20<sup>th</sup> January, 2013, along with Secretary Claire Blackford and Vice President Allan Greenwood. The main issue they talked about at the meeting was the changes to the constitution; all leagues are looking at this at the moment.

Pool Victoria said that when they receive sponsorship from the governing body, they need to have so many members to receive this sponsorship and they raised the issue of how to increase their membership as you need to be increasing your membership base each year to keep receiving this sponsorship. Some suggestions were made.

They also talked about issues they had with their Treasurer who was trying to take money from their league but they've dealt with this issue now thanks to Andrea Bird. We suggested they do a back ground check on anyone who is elected to that role in Pool Victoria. They have had problems before back in 1999 which brought down VEBA due to the treasure at that time. President Andrew O'Neill stated part of our registration goes to Pool Victoria, about \$1,800 last year (it's in the Treasurer's Report). There fees were \$7 last year and they have not changed this year.

# **Notices of Motions:**

# **Constitution Rule 11. Annual/Special General Meetings (4) (e)** to consider other business of which one (1) weeks' notice has been given to the Secretary.

President Andrew O'Neill informed notices of motions are potential changes to our By-Laws, which must be passed at the Annual General Meeting and require at least 75% of the vote of the registered members present at the meeting.

1. By-Laws Amendments (see attachment).

President Andrew O'Neill informed the black print is the existing information, the red print is potentially to be removed and the green print is potentially to be added to the existing By-Law. The first By-Law proposed change is:

- a) By-Laws General. 6. Number of Teams. Andrew O'Neill stated this change is due to the difficulty we had last year going to 3 divisions in the Winter Competition of 2012, this required a special meeting to do so. This change will enable to the league to have 3 divisions if required or even 4 divisions if there are sufficient teams that would require this. Andrew O'Neill stated it has also been included there that this is not necessarily required for Summer Competition, as this will allow for the league to run groupings or other formats as decided.
- **b)** By-Laws Rules of Competition. 11. Emergency Players. Andrew O'Neill informed there has been controversy regarding this issue so this change will hopefully clarify things for people. This rule was brought in for people who just wanted to fill in for teams who fall short.
- **c) By-Laws Final Series. 7. Markers.** Andrew O'Neill read out this proposed new By-Law and stated everyone knows this already happens but it was thought it would be best to include it in the By-Laws.
- **d) By-Laws Final Series. 8. Dress Code.** Andrew O'Neill informed these points have been added to this By-Law due to issues in the past where people have breached the dress code but it was unclear who was to address this and enforce it.

President Andrew O'Neill stated he will move all the By-Laws amendments in the one if no one objects to it, just to make things easier. Andrew O'Neill asked if anyone had any questions or were against any of the amendments for any reason. No response.

#### 2. By-Law - General. 13. Representative Teams Selection (see attachment).

Scorer Wayne Van Heerewaarden read out the current By-Law including the proposed changes, and stated this change basically looks at how we can select players for Country Cup and Interleague competitions, as opposed to the way players are currently selected. Wayne Van Heerewaarden stated players are currently selected based on quite a subjective process and not necessarily on their current performance. Players in the past have missed out and not been chosen even though their performance has been to a standard whereby it would be fair and reasonable for them to be chosen. Players who deserve to be there haven't been picked. This change also gives Division 2 and 3 players an opportunity to be picked also based on their performance, previously these players have not even been considered. Wayne Van Heerewaarden stated it's fair that Division 2 and 3 players are considered and are given a crack if they deserve it based on their performance. Wayne Van Heerewaarden stated the main goal of this change is to ensure that players, who deserve to be selected, are selected. The following issues were raised and discussed in relation to this proposal:

- **a)** A Team Manager would be required if the highest ranked players are to play first as there may be issues with this.
- **b)** The selection process used to be based on rankings and there were problems with this.
- **c)** There have been issues with high ranked players not being selected when they should have been.
- **d)** This system is non-subjective which is seen by some as a more appropriate system.
- **e)** There is a conflict between the points system rating a state player with a higher number of points for 5 years however in this selection process they are only selected automatically for 1 year. This is because they are for a different purpose altogether.
- **f)** We want to have our strongest side selected.
- **g)** There may be a disadvantage for some players who miss a few weeks in the season as this would affect their individual rankings and therefore whether they're selected or not.
- h) Andrew O'Neill and Wayne Van Heerewaarden looked at the top 30 ranked players in Division 1 from the previous season, took off 2 weeks' worth of frames from each player to see how much impact missing some of the season would be, there were only 2 players affected so the impact would be minimal.
- i) Could percentage be considered for selecting players? Percentages vary a lot and were considered and have been included in the system.
- **j)** We've won 6 out of the last 7 years in the Country Cup with the current system so it's obviously not that bad.
- **k)** Given weaker players usually play 5<sup>th</sup> each round their rankings could be better than a stronger player and therefore if the selection process goes on rankings, you won't be getting your best team selected to represent the Association.
- Weaker players don't always play 5<sup>th</sup> each round, this claim is not necessarily true. Secret ballot occurred.

#### 3. By-Law – Rules of Competition. 7. Points System (see attachment).

Wayne Van Heerewaarden explained the points system and the arguments for this system. Wayne Van Heerewaarden and Andrew O'Neill have contacted some of the metro leagues who currently have a points system in place, and their feedback was very positive and felt that although the system was initially difficult to put in place, most players have accepted and are happy with this system as it makes the league more competitive and means any team could win the finals which makes for a more competitive league.

This system also restricts higher ranked players, playing in a division that wouldn't be appropriate, so it's about protecting the divisions as well.

Andrew O'Neill stated he believes the league isn't as strong as it used to be, especially in Division 1, and this system would strengthen the league and encourage some of more experienced and highly skilled players to train and mentor some of the newer players to improve their skills. This would lead to strengthening the league. This system also restricts teams from getting too strong and dominating the league, which will make it a more competitive league.

The following issues were raised and discussed in relation to this proposal:

- **a)** This system has been adopted from other leagues; this was seen as the best system that's out there at the moment.
- **b)** This is a self-regulating system so can't be influenced by anyone; it is purely based on performance.
- c) The points for each player would be set at each Annual General Meeting.
- **d)** The teams are being submitted tonight, what if the points effect the team's entry into their desired division? The season is not going to start until April so there is plenty of time for teams to look at where their players are at and the Executive Committee can assist with any queries or adjustments that might need to be made.
- **e)** Andrew O'Neill and Wayne Van Heerewaarden have looked at the possible impact on teams in each division and feel this system won't make a huge change to most teams, will only affect a small number of teams.
- **f)** Concern was raised that this system will effect only the top 2 teams in division 1, why not drop the points allowed in each team so it effects all teams in division 1? Andrew O'Neill informed it will most likely effect the top 4 teams in division 1.
- **g)** Players might start dropping frames. There would be no purpose to this as each player stays on the points assigned to them for the whole year.
- **h)** Where do the players go that are dropped from teams that have too many players on higher points. This system crucifies teams.
- i) There are 2 state players in the one team; it makes them hard to beat. If you want to beat them go out and practice.
- **j)** It might be a disincentive to skill up newer players because if they improve and their points increase, they might have to then move to another team.
- **k)** Some highly skilled players who have work commitments etc which means they are unable to play a full season, will be assigned lower points even though they are highly skilled players. This can create an unfair advantage to their team.

I) This system will break up teams. Andrew O'Neill stated this is not the case, teams who are overloaded with players due to points, will need to look at one player going out and one player coming in, that's about it. This system will not "break up" teams. Andrew O'Neill stated there's a flipside to every argument, everyone has heard the arguments for and against this points system so it's time to vote. Secret ballot occurred.

# Around the Executive:

#### 1. Presidents Report.

# 6. Publicity Officer's Report.

**a)** Sponsorship for 2013. # **General Business:**

- 1. Scorebooks for winter competition. President Wayne Van Heerewaarden stated if teams have used their old scorebooks and need a new one they can come and see Wayne to get one however if teams have lost their scorebook from last winter they will need to purchase another one as some teams have recurring issues with losing their scorebooks. Andrew O'Neill confirmed there is a motion on the books that if you are a new team or have used your scorebook you are able to get a new one however if you've lost your scorebook you will need to pay \$10 for a new one.
- 2. Association Handbook 2013 hard copy or electronic only. Wayne stated this is a great expense to the league printing out a heap of handbooks each year so the proposal at this meeting is to print out only one per team, one for each venue and no more than that, to reduce the cost to the league. Wayne asked if anyone wanted to speak for or against this proposal. # **General Business:**

1) We got to the point of requiring a new Executive Committee because of many reasons. It is not the results of one person's actions. It is not because of the event that happened at country cup, it was a combination of events that got us (the league) here. This will not be an open forum for people to air grievances or make allegations. We don't want to dwell on this situation any longer. We want to move on and continue to play pool because that's why we were here in the first place. If a problem does arise please put it in writing so that the Executive Committee can deal with it.

Wayne took a few questions which asked about the racial complaint and some members were worried about how words said at this event reflects upon the league and them as members within it. Others wanted to know exactly what happened. During the course of these questions Wayne Taylor continued to tell members that our Executive Committee situation was not caused by this one situation alone and that we now have our social and media policies in place to remind members that this behaviour will not be tolerated in this league. Brad Smith then commented that our policy states that we are not allowed to discuss individual situations at an open forum. Wayne Taylor then agreed and said that he won't be taking any more questions. Mick Lubawski then asked if and how Pool Victoria had contributed to any complaint or proceedings. Wayne Taylor replied, absolutely they have. We have been consulting with them on more than one occasion and they continue to provide support and advice to us (the league) especially concerning legal proceedings.

Simon Alice then made a complaint about previous meeting and fines. He was asked to raise his issue again in 'Around the Committee'.

Alan Greenwood then aired that he had a personal grievance about words said (at the Merton Rush) and expressed anger about someone calling the league racist and that it reflects badly on the league. He expressed concern that there were women and children present on the day and that he thought the behaviour was inappropriate. Wayne Taylor tried to reassure him that we now have policies in place to deal with these people and that the league needs to move on. Alan Greenwood became angry and walked out expressing his disgust and his opinions as the left the room. Wayne Van Heerawaardan and Rick Merlo expressed concern repeatedly and that he wants assurance that legal actions won't be taken in the future. Wayne Taylor told Wayne Van Heerawaardan that this can't be done. You can't tell people what to do. Wayne Van Heerawaardan suggested that we amend our constitution to require that people must follow the league procedures and resolution process and at least give the league the chance before resorting to legal proceedings. Wayne Taylor replied we are not doing that and told the room that we've dwelled on this too long and are moving on.

- 2) Wayne Taylor continued to say that it has been brought to our attention (Executive Committee) that some players are playing in teams that they are not allegeable to play for. We will be investigating these complaints and examining score cards and penalties will apply. Complaints can be made and taken in writing. The rules state that people playing outside their divisions will have their matches scratched and points will be altered. Dave Britt asked what the criteria for ex-members to resume playing is and is he allegeable. Wayne Taylor told him that the Executive Committee will make investigations and notify him.
- 3) Wayne Taylor continued, the next thing is Presentation Night. We are asking for and taking submissions for either Friday the 13<sup>th</sup> September or 11<sup>th</sup> October. We require prices for venue hire, a meals menu, a drinks menu and price lists for both. We would appreciate 2 weeks' notice so that a decision can be made next meeting. For 150 people. Mick Lubawski suggested that we (Executive Committee) ask for written quotes to make it easier to compare them. Wayne Taylor agreed that a written quote would be preferred.
- 4) Pool Victoria is holding a Pool Vic health event, says Wayne Taylor. He asked members to email him the details of anyone who wants to enter so the committee can put teams together, fill in entry forms and enter teams. They will be hiring a mini bus if there are enough people. Peter Simpson added that the country cup committee will decide the makeup of the teams.
- 5) The next point on agenda is registrations and fees. (Wayne Taylor) He then asked Paul Pike (scorer) if he had anything to add. Paul Pike said that some teams were missing scorecards. Those teams are the Elites, Uglii's, Turk's Thunders. They will all be fined accordingly. Turks Thunders claim that they placed their scorecard in the box so it's missing from the box. They

were reminded to put their complaint in writing and we (Executive Committee) will look at it. We are trying to get to a point where we show up on Tuesday, play pool, be decent to each other and draw a line in the sand and leave the past in the past. There was a serious issue raised, the racism, it has been raised and dealt with. It had to be dealt with post haste. In the eyes of the law we were waiting to be crunched on that. The petty backwards and forwards needs to be stopped. It has got to be over now. I want to clear up a few points. Assertions have been made and I, with the Executive Committee, have investigated and need to clear up for legal reasons. There is no benefit to the league to continue petty arguments. Personal grievances and arguments are up to them to handle outside of Latrobe Valley Association beginning now.

# \*\*\*President Wayne Taylor has written a statement regarding things brought up at meetings that I probably haven't addressed soon enough.

There is a belief held and circulated by some members that the blame for the recent cancelation of pool lay at the feet of Milo Fue.

The new executive committee have looked back over this incident in a fair amount of detail, and are united in the opinion this was not Milo Fue's fault. Milo's part in this saga was simply to raise an important issue and continue to push for it to be handled appropriately.

There is a belief that Milo has done the wrong thing in the manner that he has raised the issue. Although not the ideal way to raise the issue, Milo has done nothing wrong by raising it on social media. The initial grievance was not slanderous or libelous in any way and no further action needs to be taken in regards to this. People have been making the assertion that Milo was doing this for financial gain and that legal action was pending. There is absolutely no evidence to support this, certain assumptions have been presented as fact, which allowed hysteria to take hold and the truth behind the reasons for raising the issue were pushed aside. After personal consultation Milo never wanted to name individuals or have people punished just wanted racial comments to stop and policies put into place. Blame lies with our constitution and our complicated rules for dealing with issues and some of the help and advice that was given to us by associations above us. **Special Business:** This meeting will be conducted in accordance with the Constitution 18. – 29. Committee Meetings. This meeting is made up of Executive Committee members and Ordinary Committee Members, ie the two nominated delegates from each team. Only the two delegates from each side from winter competition may vote. Anyone who was not a delegate please refrain from voting as this is a Committee Meeting.

**1)** We LV8BA received a letter from Wellington 8 Ball Association. The league which covers the Sale, Maffa area. (Letter of correspondence read) They have had an incident happen within their competition and they have dealt with it. Our Constitution reads that (Wayne Taylors understanding) we don't deal with that further again. They have given their penalty as it was under their jurisdiction, and the courts to decide anything further. We are not here to decide should he have done it of if he should be suspended for the incident or any of those questions. We are here to discuss the fact that a member of our association has been banned from a pool competition for ten years, does that bring our league into disrepute. Our purpose is for the promotion of good fellowship amongst competitors and the eligibility for membership of our association. (Constitution 5(1)) You can only be a member of our association if you believe in the promotion of good fellowship amongst competitors and the

advancement of the sport in general. Then we get down to step 9 (Constitution 9 (a,b,c)) discipline, suspension and expulsion of members. We have to decide whether as a committee, based on the fact that someone has been suspended for ten years, not based on the evidence of what may have happened, is that guilty of conduct unbecoming a member. It's up to you guys to decide as a committee and then the next step is deciding on a penalty, fine, suspension or expulsion. Firstly, does anyone have any questions?

Graham Hodgskiss - As he wasn't representing our league at the competition how does it then come back to us. You are all representing our association/league. If you're partaking in an eightball tournament, whether you're playing specifically for our league or not you are undertaking that sport as a member of our association. Any sport that follows on from our association, any cue sport, including snooker or trips away. Anything to do with the sport and activities that come out from our association, yes they are actually representing our league. Snaz- Was he provoked and was there a police charge?—Wayne Taylor cut him off because we are not here to discuss the actual incident. What we have is a penalty. Yes there is a police charge and that is who is going to deal with questions like was there this or that or anything else. What we are dealing with is someone from our association has behaved in a manner that has caused them to be expelled for ten years from a tournament and to be taken from that tournament.

Anthony Van De Burgt - This is not the first issue we've had from him is it? This is the first issue on the record. Everything else that has happened before, we are not going to use precedent or anything else that has happened before because we are starting a fresh. I understand what you are saying but we are going to go by the book, clean slate, this point forward.

Wayne V- I think it's fair to take away who it is and look at what it is.

A Player. If I came in and didn't mention a name you'd all be more worried about finding out who it is instead of dealing with the issue. Take away the who. All it was, was a member of ours got suspended for ten years because of their behavior and we'll leave it to the police to sort out for themselves.

Peter Simpson- One thing you've got to remember too. We rely on a lot of sponsorship as you just realized in the last season I just signed a major one. Now I have had sponsors calling me up since this incident. What's this I hear about one of your players, Tazie. It's all around the town here and that's not a good look, ya know. We are trying to better ourselves and promote the game and when businesses hear that sort of thing going on they, ask if it's like the things that used to go on in the sixties and seventies, I said "no, no it's just an isolated incident." But I'm not commenting on it anymore, but I said it will be dealt with. I am just saying you've got to take that into consideration to that we're trying to promote our league all the time now, trying to help juniors out which we just had recently then they see something like this happen and it looks bad. The main thing is that we could lose all our sponsorship.

Mick Lubawski - They came up with a figure of ten years, how'd they come to that? Wayne T -They have looked into the incident and that's theirs to come up with. Mick- What's happened for them to go, why wasn't it just a couple of years. If someone gets murdered they get ten years. He's obviously done something wrong to that bloke that he's not saying nothing about that they've slapped him with that.

Duane Morrell - Because it was a major incident, ya say ten years.

Wayne T- I'm not going to make any accusations but your right in what you're saying, they don't give you ten years for breaking ya cue early. It's all irrelevant to what we are trying to look at.

Rick Merlo- Let's Vote

Wayne T- You are only voting on whether a ten year suspension warrants a fundamental.

Mick Lubawski - Half the people don't know what it is.

Wayne Taylor - you don't have to know what he did. He got a ten year suspension, that's what he did. Everyone stop. We will take questions one at a time.

Wayne Van Heerewaarden - We've just got to work out whether we want him to be punished or not. Does he deserve to be punished yes or no, that's it.

Wayne Taylor - No Its for getting suspended from a pool tournament for ten years. The rest is not our place to say or judge.

Andrew O'Neill - Look everyone probably wants to know the whys and how's about it but what Wayne is saying is right on the money. A guy has been suspended for ten years who cares why they come up with that figure, that's their association and they did it for their reasons. We've just got to look weather he's brought our game

into disrepute. That's what our constitution says, the letters been written, we just have to address it. Weather he has brought our league into disrepute. You can say it's an event that had nothing to do with us, that's true but at the same time everyone knows who he plays for and who he's represented. Taz represents us on a country cup level so we have to consider that. He did come up against the committee before and as an error on my part he got off I think we need to listen to these guys and what they say about whether he's brought our league into disrepute. If you're think he has on the information you hear today on that and that only, if you don't, you don't. Other than that let's not banter around too much.

Ann Rockall - I was at Bairnsdale, I was at Sale as well. They know I play for this league and they have come up and asked me if anything has been done about him yet, I said no, it's in the pipework's. They are just appalled that it's taken so long.

Wayne T- We are bound by our constitution to do things properly and I won't rush it because people in Bairnsdale are appalled and do it wrong. It has been done wrong before and I won't do it wrong and people have snuck away.

Rick Melro - Can you explain how that's any different to two people from our league go out to a night club and punch on and they are known members of our league in our community.

Wayne T- They weren't playing eightball or wearing Latrobe Valley shirts so they weren't representing our league or after an eightball event. I can't find a just reason to look at that. He was at an eightball tournament playing eightball.

Claire Blackford- I just want to make a statement, it's not just a ten year ban we are taking into consideration it is also the sponsors and them asking the question now about what's going on in our league so there's that of course to take into consideration as well. It's quite clear to me that he has taken this sport into disrepute cos we've got our sponsors are asking us what's going on, they are going to think twice about sponsoring us next year, and in future. So yes it's brought our league into disrepute.

Peter Simpson- It's just not the sponsorship, the thing is that it made the Sale papers and everyone knows. I got back Sunday night and went down the street and people knew about it and what transpired. All the football clubs know about what happened. My son is on the committee at Gormandale and he rang me to ask what was going on. As an Executive Committee member here as far as I am concerned he has brought our league into disrepute, weather you disagree with me or not, I don't care as far as I'm concerned he has.

Maria Schiavello - Even though we play pool this is a sporting club, we follow the same rules as any other sporting club, just as we do in netball. You play in their league, even if you play elsewhere you still play in their league. They muck up they are going to be disciplined. You are always representing that league. Wayne Taylor - yes, absolutely, that's what's happening here.

Duane Morell - Taz doesn't only play in this league, he plays in other leagues. The only thing I am a bit vague about it is, what are they doing about it? My question is what is Pool Victoria doing about this? They come to us and want us to get membership, he also plays in other leagues so why is it us, why do we have to deal with it? I am not saying we can't help with it, don't get me wrong, but he has had so many misdemeanors in this association and I'll tell you now he's done some horrific things in this association ...... Wayne Taylor - We are going to try and not bring those things into it. Duane Morrell - Where's Pool Victoria in all this?? At the end of the day they are our governing body and we pay our membership so what are they doing about this?? It is a state thing!

Each league will decide what they are doing and send their letters on to Pool Victoria and they will have a hearing and decide from there. We are the first step. They follow us. Melbourne may be doing something as well. I don't know. I think Wellington will send Pool Victoria their letter to, only Leon their president can answer that. We are leasing with Pool Victoria all the time. We are following all the steps so that it is done right. It comes down to a simple thing, first of all, we need to vote, do we believe he has brought this league into disrepute? Majority vote, only those winter delegates can vote. If you are unsure or don't understand, refrain from voting. Do you believe a player from this league, who has a ten year ban for an incident at a pool tournament has brought this league into disrepute? Yes or No

Ash Vogt - representative from Wellington- This incident has, I actually ran the Gippy Cup and it has brought a lot a lot of shit on us. We no longer have a venue, we are finding it hard to get a liquor license, we have lost every sponsor already, all of them. Two teams said they won't be coming back and basically, I am great mates

with Taz, but for him to do that and even this other bloke, we are still in discussion about whether he provoked it and weather we ban him as well. When you decide on a vote, I'll be voting, I won't say what I'll be voting, but he has stuffed up and we have a lot of work to do to find all out new sponsors so please consider that. Wayne Taylor - So we will move on to a simple show of hands.

Do we believe the actions of Chris Johnson for getting himself barred for ten years from the Gippy Cup has repercussions and reflections on our league. Has it brought our league into disrepute? Vote Taken- carried

After we send Chris a letter, Chris has the right to request a meeting to say anything he would like to offer and put his case forward. Then if we uphold our decision, he then has 28days to request a General Meeting with every member of the association present to put his case forward, then we vote again. This is just the first step in the process and this will take time.

Qn- Should he have been here tonight

Wayne T- No. He could have come if he wanted to but he wouldn't have been allowed to speak in his defense. We are dealing with the letter.

Next step is to decide the penalty. A fine, a suspension, an expulsion. Expulsion means next season he can request to be part of a team and the committee looks at it. Disgression is up to the committee at the time. It is very messy. I don't believe in fines, they mean different things to different people. Fines are never a fair penalty. Wayne V- Couldn't we pass fine money on to Wellington to help out?

Andrew O- I disagree, we had a situation where a member got another member to pay a fine and that defeats the purpose.

Qn - Shouldn't the police be dealing with this?

The league needs to be seen to be doing something. The police deal with the assault part of it.

Vote on Fine / Suspension / Expulsion

Only vote once

Suspension for specified period- carried

Vote for period of time

2 years - carried

Suspension starts at the end of all his appeals. He has two weeks to make his first appeal. He may continue to appeal as long as he likes.

We now need to send him a letter informing him of all this.

We can't under our constitution impose further conditions other than suspending him from membership. Like proving himself.

b) Players having played for more than one team are only be eligible to play finals for the team they have played the most games for. The original rule was to stop teams from sitting their players out and bringing in better players and paying them to help you get a few extra wins and bumping you up. D) still remains the same. The executive reserve the right to change results if this happens. This rule change is for those who filled in at the beginning of the season who weren't already in teams and have now found themselves in teams and wanting to represent their new teams in the finals. As it is these people are ineligible to play finals. Don McIvor- Commented if this gets in the MRSL would have a field day. Players would play two games here and there for teams and decide to play for those in the finals.

Wayne Taylor - You wouldn't get away with it because the executive committee still reserve the right to change results for stacked teams. Executive wouldn't allow it. If you cheat all that players results would be removed. You must play five games for a team to be eligible for the finals.

Final comment from President Wayne Taylor. The only reason I am here as President, I swore black and blue that I wouldn't do this again, is to try to put some rules in place and get people following to get us through the season so that next AGM someone else can take things over and run it. There have been major changes within the last year to the constitution. Currently we have to inject model rules into our constitution to make it work and it makes it ugly. Once that new constitution is in place it becomes the Executive Committee's obligation and job to understand it and to execute it. The rules are clear and set out on how our association has to operate to keep ourselves out of trouble and not get to a situation where we can't play pool anymore. Those situations come solely not from the incidents that arise but from our ability to deal with them. If we follow the constitution we currently have it is long and drawn out and difficult. Sorry I have to drag you through these meetings, but they have to be done a certain way and I do get angry (sorry to Andrew) when I am told that I am not doing them right when I spend hours of my own time making sure I am doing it right so that if it's appealed further down the track it does get upheld. In regards to that, like me, dislike me, I don't care you won't have to put up with me next year. Let's just get to the AGM and keep things running till then. If I am putting you through boring shit meetings then I am sorry but we'll get through them and I am doing it for a reason. Under the new constitution, our committee set up is bizarre, 200 odd members and 60 odd committee members that's crazy. Generally for a club/league that size you would have seven committee members. Because it was built into our constitution that two delegates from each team form the committee, that was fine when there was a maximum of twelve teams but when we got out to nearly 30 teams it makes it very laborious to try and get everyone together at the same time and focus upon the issues that need to be dealt with and to understand them fully. Under the new constitution, we will set how many committee members there will be but recommendations from consumer affairs vary between 7 and 15. 15 being a heap. Currently we are running at about 60. So the committee will actually be cut down to include basically an Executive Committee and six or seven other delegates roughly, it might be four or it might be 10, roughly. Committee meeting will be able to be called and held at someone's place where the issues will be dealt with and when we need to get everyone together to decide on it will be general meetings and special meetings. But the Committee Meetings will be held in house and we won't have to get everyone here because half the time we don't know whose committee members and whose not. The understanding that people should have is if you are one of the two delegates from the team then you're a committee member with as much responsibility and liability as everyone on the Executive Committee. It is a position where you are supposed to understand every single rule in that book and you are responsible for all of us up here making sure every rule in that book is followed and that's where the difficulty is. We've got a committee of 60 and 30 of them I don't even think care about the rules anymore, they'd rather be just playing pool so let's make them not be committee members anymore. They don't want to be a committee member. Let them go. We've dragged them in because our constitution says we have to. Choose your members carefully! This is state legislation not just us deciding this. This was brought in because a lot of sporting clubs have ended us like us.

Wayne Van Heerewaarden - Put some thought into who we vote in, think very carefully about who you want representing us. Spend some time talking to people and find out what their thoughts are.
