Around the Executive:

President's Report.

- 1. President Scott Kersten would like to thank everyone for making it a great year. A special thanks to all our venues and sponsors who are always supporting the league. Also, an extra thanks to the Committee for all their help and support during the past season.
- 2. Also, congratulations to Suzanne Allan and Angela Van Rossum for finishing runners up at the Victorian State Doubles championships on the past weekend.

Vice President's Report.

- 1. Vice President Andrew O'Neill spoke about the other pool league at Kaptain 8 ball after a number of members had asked him about them not being an incorporation and if this was legal. Andrew has spoken to someone he got to know at consumer affairs after doing the constitution about being an incorporation association. Basically, they don't have to be an incorporation association to be an association/league. They are open to liability and can be held personally accountable in a court of law. In an Incorporation Association unless of course you break the law for example the treasurer runs off with the money, you are protected personally from accountability, hence the reason why back in the day when the government introduced incorporated association why associations became 'Incorporated', this is how the state government controls associations. He also said it is also it is very unlikely they could open a bank account in their league name as well as other issues.
- 2. Kirk Williams down at Kaptain 8 ball has complained to us that it is unfair that he did not get an opportunity to host the Summer Competition finals and that he was under the impression that all events would be split between his venue and Turks Bar, saying that this would be fair for both venues. Andrew has talked to Kirk about this and told him that we are an Association made up of members who are represented by the Committee, not the venues or sponsors. The issue with Kaptain 8 ball is that through his sponsorship he is expecting this to happen, but unfortunately for him the Committee sees it differently, as far as we are concerned it's a numbers game and the facts are that Turks Bar had 12 teams (60 members) to his 3 teams (15 members) in the Summer Competition and even more so the Morwell RSL had 6 teams (30 members), so if it had come to a vote by the members you would easily see where this would go. I've told him on a number of occasions numbers, numbers, numbers and that he needs to get more teams out of his venue. I also told him he had two options either accept the decision or don't sponsor the Association next year, and therefore not have to worry about event hosting. He has not accepted this and thinks it's unfair and gave Scott back the banner we gave him as he requested one to be put up at his venue, so we had one made up at the cost of his sponsorship. We can expect no sponsorship from him next year either and he was quoted by a Committee member one night calling the Committee a bunch of c*#ts which I personally take offence to as we have never spoken to him in this way and I think it's very unprofessionally of him as a business owner of a sporting venue to speak this way about the Committee. I just wanted to take the opportunity to brief the members of the Association on what had actually transpired and to let you know our versions of events and the reasons why in dealing with him on this matter.
- 3. Going forward, we've been talking about going to 5 frames for division 1 and maybe even division 2 if there interested, there is a definite interest in doing this from the members. We would play across two tables to reduce time, we are expecting this to take as much time as we take on a normal pool night of 15 frames starting at 7pm. We would also look at playing on a different night to accommodate the format, but this also will allow room for the league to grow at the venues. We will be looking at doing this for the next Summer Competition to try it out and if successful carry onto the Winter Competition with it. Also we would be introducing this with a basic points/handicap system to keep good and ongoing competition. Something to think about and to look at for that competition later on in the year, we will start working on this soon looking at all our options in going forward.

4. I will not be on the Committee this coming year as with some of our other experienced people like Rosa we will be making way for some new fresh faces who are interested in having a go which is always good for the Association, as they bring new ideas and a fresh approach to the Committee. I wish to thank to all the members and the Committee for all their help and support throughout the year.

Annual Subscription Fees:

- 1. **Match Fees:** Scott would like to raise the match fees of this Association. Janet Hedt has asked what the expenditure of the fees was. Scott broke it down and explained it to members present. Numbers where down this year for the Annual Presentation Ball and Scott believes that the cost of the night was an issue with members, for both their payment as members and also the cost of their partners. Member's numbers were down with 98 people attending and even more so of a concern were the partners with only a hand full (16) attending.
- 2. Neil Stuckey has talked about the way the league subsidises the alcohol. He thinks that too much emphasises is put on alcohol consumption and that is not good, it's a bad look for the league when people behave like they've been doing. He believes that we would be better off if members pay for their own drinks.
- 3. Peter Simpson said that presentation night was originally organised so that the night was a night out for the wives/partners of the members of the Association. It is meant to be a night of fun for everyone.

This was discussed at length by members present.

- 4. Scott Kersten has suggested that we should change the match fee to \$7.50 per round. Dave Buhagiar has suggested to change it to \$6.00 per round. This was discussed by members present.

7. **Pool Victoria Affiliation:** The affiliation fees for Pool Victoria are still \$7.00 per player. This was not changed at their Annual General Meeting for 2017.

Other Business:

1. Pool Victoria AGM Report:

Andrew said that he had spoken with Andrea Bird of Pool Victoria about their Annual General Meeting and said that Pool Victoria were looking at starting to implement the 20/20 time rule in some competitions. When Australian Eight Ball Federation (AEBF) bring that rule into play we will look at bringing it into the league. Danny McLean has asked why we can't use it now. This was discussed by members present. This is something that Danny and Scott will look into for the future.

2. Special Resolution: By-Law Reforms

- 1. Andrew O'Neill takes the floor to talk about the By-Laws of the Association and how for the past year he has been reforming these By-Laws since last year's Annual General Meeting where he requested with the Association permission to do so and present them here at this Annual General Meeting for consideration. This had to be done after we had completed the Constitution reforms as now some of the By-Laws conflict with the Constitution and also, they have been in need of reform for a while now as things have changed in the Association. They have been uploaded onto the website for all members to view for three or four weeks now. Please take the time to read through these reforms if you can as he has changed quite a few things. I do apologise as I would have liked them to have been up earlier and also would have like to have spent more time on them but personal issues (becoming a dad) took up a lot of my time last year. So, no doubt there could be amendments in the future as we start to implement these changes.
- 2. Danny McLean has asked if the changes to the By-Laws are in red? Andrew explained that he has pretty much amended the entire document in some way, very few clauses were left untouched. It's basically is a whole new write up.
- 3. There is a section in there about the responsibility/expectations of the members of the Committee and what their positions involve. These are **not** By-Laws but were added in so that members can see what's involved in each role, I've been asked by a few members for this so that people thinking of taking up a role can see what's involved. It has the same look and feel to it as the Constitution. There's a page also dedicated to explain the reasons why we need By-Laws and also the Committee, which is worth a read if you do not understand the set up and how Associations are run. There is a page that lays out the general structure of the Association on how we run and do things. I've added a table of contents as well so that you can find things much easier as there is more content. There are also forms at the back, we have added clauses in there of things that we do but are not written down anywhere, for example how we do Player of the Year.

There have been quite a few changes/amendments and also a few new clauses, Andrew then pointed out a few of the important ones.

- 1) Changes about how player can go down into a lower division and the new form for this.
- 2) Changes to reimbursement.
- 3) Changes to emergency players.
- 4) Changes which allow lower division players to be a fill-in for higher division teams during the Sumer Competition etc.

- 4. PLEASE MAKE SURE YOU READ THE NEW **BY-LAWS** it's on the website, you have all been warned of some of the changes going forward, don't get caught out as the penalties can be pretty server.
- 5. **1**st **Motion:** To accept the new By-Law reforms.

Andrew said now that the Association has done the Constitutional & By-Law reforms I will organise a book to be printed for each team and venue so that everyone has access to a physical copy and not just to the digital copy on the website.

6. **2nd Motion**: Removing Player of the Finals and amending Player of the Grand Final. Andrew said he wanted this to be a separate motion to the last one as this is a big change as this award has been going since 1972. Player of the Grand Final will have to be amended if we remove this By-Law as its wording is attached to it. Scott Kersten spoke about this and said it's an easier and fairer to have a Player of the Grand Final instead of Player of the Final series. Peter Simpson and Paul Pike also spoke for the motion too and was discussed by members present.

Motion to remove Player of the Finals and to amend Player of the Grand Final.

The above mentioned resolution was put in place due to the Latrobe Valley Eight Ball Association having received a number of complaints regarding your actions and behaviour during the Summer Competition finals day on March 5th 2017. These complaints have been received verbally and include a formal letter of complaint, detailing the following:

1. Acting and speaking aggressively and disrespectfully towards a member of the Committee of the Association (Vice President). Your outburst was disrespectful and disrupted another divisional finals occurring at the time on an adjacent table;

- 2. Disrespect and poor sportsmanship shown towards Hayden Clarke and his team whilst playing your games against him in the grand final, calling him a "cheat" and then refusing to shake his hand after the match; and
- 3. Disrespect and poor sportsmanship shown in front of the Association members and sponsors present on the day who were witness to your behaviour. You were also arguing and acting aggressively towards another member of the Association.

Resolution:

- **1.** That Steve Gray will no longer be eligible to play representative games for the Association for the 2017/18 calendar year. This includes Country Cup, Interleague day, Vic Health Carnival and representing the Association at tryouts and playing at State and National levels.
