The President Wayne van Heerewaarden handed the floor over to Andrew O'Neill to conduct the special business received. Andrew said that the notice of motions have been up on the website as per the constitution requirements. Andrew handed out paperwork that explains by example the changes proposed in a four-step process. Andrew then discussed the proposals with the members explaining how the whole system works and why he is proposing these changes going forward and as well as taking and answering questions from the members. The proposals were discussed at length by the members and were generally accepted by the members with the only concern being with the handicap table being changed and how that will play out over the season. Andrew made the point as to why he believes it should change and said that if it does prove not to work out that being too hard, the motion proposed above will give the Committee the ability to wind it back if necessary for the Summer Competition season. I expect there to be no more major changes to the format or the handicap system going forward. All the information that a team will need will be in their score book and also on the web site -

Below are the changes to be made to the official By-Laws of the Association.

36. Point System (Grouping/Handicap)

36.1 The Point System shall be controlled by the Committee and used for Division one (1) in competition seasons and if necessary, may be considered for other divisions.

36.2 **Grouping**

36.2.1 The Grouping number determines the handicap points for players in each group. The criteria used in the allocation of players into groups shall be as follows:

36.2.1.1	Group 1	These are the highest grade players. Players are worth 1
		handicap point. Ranking average 70% - 100%.
36.2.1.2	Group 1.5	These are the high grade players. Players are worth 1.5
		handicap points. Ranking average 60% - 69%.
36.2.1.3	Group 2	These are the medium grade players. Players are worth 2
		handicap points. Ranking average 50% - 59%.
36.2.1.4	Group 2.5	These are the low grade players. Players are worth 2.5
		handicap points. Ranking average 40% - 49%.
36.2.1.5	Group 3	These are the lowest grade players. Players are worth 3
		handicap points. Ranking average 0% - 39%.
	36.2.1.2 36.2.1.3 36.2.1.4	36.2.1.2 Group 1.5 36.2.1.3 Group 2 36.2.1.4 Group 2.5

36.2.2 Any vacancies and forfeits on a team score card are worth 2 handicap points.

36.3 New Players

- 36.3.1 New players and players in all other division will be automatically graded into group three (3). The Committee may decide otherwise after taking into consideration a player's ability and or history.
- 36.3.2 New player grouping evaluation may be considered by the Committee half way through and at the end of their 1st season.
- 36.3.3 All new players must complete a registration form and answer truthfully the questions about their previous playing history (this will be checked). The captain must sign to verify the registration form has been filled in correct, fully and truthfully. If it is found that the registration form has been completed untruthfully (mistake or otherwise) then that player will forfeit all frames played and these frames will be granted to the opposition player(s) for all matches played.
- 36.3.4 All players are to be grouped before they are eligible to play. Playing a player without being allocated to a group will result in all of that players frames being forfeited to the opposition player(s) for all matches played.

36.4 Ranking Average

- 36.4.1 A players ranking average shall be calculated over their first two (2) seasons played of rankings under the match format played, the Committee to evaluate.
- 36.4.2 A players ranking average shall be evaluated over their last three (3) seasons played of rankings under the match format played.
- 36.4.3 Minimum of five (5) games played in a season to qualify for a player's ranking average.
- 36.4.4 Ranking Average calculation: wins/games played x 100 = average percentage.

36.5 **Handicap**

36.5.1 Using the official Team Handicap Table if a total grouping point's difference exist between the two competing teams the value of the total grouping point's difference in frames shall be taken from the team with the lower total grouping point's and awarded to the team with the higher total grouping points at the end of the match to give a final score. Frames a team shall earn or lose on the night is capped between 0-16 frames.

Competition Rules

45. Emergency Players

- 45.1 A player may play as an emergency player over the Summer a season of competition.
 - 45.1.1 an emergency player cannot play in a lower division, they may play for more than one (1) team over the Summer a season of competition;
 - 45.1.2 they do not have to meet clearance requirements to change teams for the first three (3) games they play for any one (1) team;
 - 45.1.3 all ranking points acquired by a player shall stay with each team that the player has played for. They are ineligible to play finals, ineligible for player of the year and all other accolades and;
 - 45.1.4 a lower division player may play in a higher division as an emergency player and therefore will still be bound by all the above requirements of an emergency player. The lower division player can still play in his/her lower division team as normal (including finals).

38. Draw

- 38.1 If in the home/away season the final score is drawn after the handicap system has been applied then each team will earn one (1) Premiership points each.
 - In an event of two (2) or more teams finishing the home/away season on the same points/frames a playoff shall occur with the game to be held at the venue of the team that is shown higher on the ladder. If the match is drawn a final series tie breaker shall to be played (see sub rule 52 Draw).

Final Series Rules

52. Draw

In the event of a draw occurring the captains will allocate three (3) players from each team that played in the drawn match, a draw shall be done according to the season order of play (see sub rule 37.1 Format) and they shall play a combined best of three (3) each player playing one (1) frame each the winning team will be the first to win two (2) of the three (3) frames.

1. President's Report:

3. Treasurer's Report:

We were able to complete both Winter and Summer seasons with one division and the new handicap system. We had 10 teams in Winter and 12 in Summer, with team numbers down quite a long way from pre Covid competition numbers.

The Association made a significant profit of \$5,467.64 for the reporting year. It should be noted the cost of trophies for the Summer season (\$530.99) is not included as it was paid after 31 March 2023, and we had credits for two teams in the Country Cup as the previous competition did not go ahead. Our publicity officer Claire Blackford did a great job finding \$1,700 in sponsorship from

Thank you to the team captains for the payment of fees. Most of this was done without prompting, and all fees were paid on time, which makes my role much easier.

The committee has been conservative in our spending this season, with costs for trophies and presentations reduced from previous years, partly due to reduced player numbers. However, it is not our intention to make large profits, and we will look to provide a more even result in the coming year.

Dean Burridge opened up the floor to questions. Ken Krieger asked about the Country Cup figures in which Dean Burridge answered by explained by breaking down the payments and what they were for. Dean Burridge also talked about the administration costs which included the purchase of the scorer's computer and software at \$1,124.

Daniel Tabone asked about the Junior's money these days, Wayne van Heerewaarden responded that currently it's sitting in the bank in term deposit we are just about to pull it out of the term deposit and move it over as we are shifting banks and we will look at what to do with it once it's in the new bank. Andrew O'Neill said that it will probably go back under term deposit again. Dean Burridge went onto explain where the junior's money is on the annual statement. Wayne van Heerewaarden went onto explain the history of the junior's fund and how we use it now. It was discussed by the members about possible uses and ideas for the juniors going forward.

Wayne van Heerewaarden said that he attended the meeting via a zoom call and he was excluded from the meeting until after the IR rules were discussed but said that he raised it up again when he was allowed into the meeting in which they tried to say that we have moved on from that. Wayne van Heerewaarden said that he was fuming at this point but remained calm but was direct with his questioning.

Special Business:

1. Summer Competition Forfeits:

Wayne van Heerewaarden said that we had some forfeits this season and it wasn't a good thing with one team in particular who had to give a few matches away. In their defence they did try to play the matches but for whatever reason the other team were unable to accommodate that or didn't want to and that's their prerogative to make as well. In moving forward when we look at taking on teams from other leagues, we are going to have to say to these teams that if your league goes and starts up before our season finishes its season you will need to make our league that priority you've committed here first and we want you to finish off that commitment here, otherwise it can disrupt the season and even affect the outcome here. There were some issues at their agm, we don't want to stop teams from other league from

playing but we want to emphasize to teams to commit and if they can't then there probably best not starting.

Andrew O'Neill said that Wayne van Heerewaarden said is right I think the best thing going forward is to get the commitment from the team and if they don't fulfil that commitment then we don't have them again as this could have blown out to be more than a couple of games and thanks to Shane's team for playing one of those games it was great that they did that but they didn't have too. The other two team we did ask and didn't do it for whatever reason it their prerogative as the rules are set that way, I would have then like to have seen the Paragon's fulfil their duty but the opted not to. I did speak to their president over there and he made them aware of the situation at their agm as he is player on the Paragon team. He said that the captains wanted to get the season going and I asked him could they have pushed it forward and he said that there was no reason why they couldn't but they wanted to get the season started which was disappointing for us. So, we need to get the teams commitment as this could have been 4 of 5 game forfeits if they had of decided to start their season even earlier.

Shane Vogt brought up a point of why the end of season competition between the two leagues stopped? Andrew O'Neill said that stopped many years ago but there's no reason why it shouldn't happen again. Shane Vogt said well that would start getting the sides back together again. Andrew O'Neill said it could be a good way of mending some bridges.

Wayne van Heerewaarden went on to say the obversely no one likes having forfeits during the season and we will do our best to not have them. David Budgiar said that it could have made a big change to the finals. Wayne van Heerewaarden said that if any teams on the night are facing the prospect of a forfeit try and talk to us and we will help out where we can and particularly now with that emergency player rule you can get players to slip in and play, we may even put together a players list.

Great event we have put a post-up on the Facebook page over a week ago asking for players to let Rosa Payne know if there interested and so far, she has about 15 names or so. So let your teams know as we are not going to chase you anymore you have to come to us and let us know that you are available, it's open to everyone. It will be at the Workman's Club it's been there before. We have three teams with seven or eight players per team so get in contact with Rosa. Country Cup committee will get together soon.

Shane Vogt asked the question about the \$50 that players got to help them out with petrol & accommodation? 

Claire Blackford went on to explain what that meant and that the player could ask anything about the new rules and that you could ask any question. We could also run some comps as well if we wanted to.
