1. Reason for this meeting was a phone call on Tuesday night from Jim McCluskey (marker) that two players Terry Barrett and Rex Grant misbehaved. The first mentioned in this report is that Terry Barrett disputed a shot and also talking back to the marker.
2. Jim McCluskey: - Reported that the Royal Exchange Hotel won the first two games of the night and lost the third, won the fourth game leading 3 – 1, and were playing the last 3 frames of the night. Terry Barrett of the Richmond Tigers was full and Rex Grant of the Royal Exchange Hotel team was also full.
