4. The President Andrew O'Neill said that firstly I would like to say is that I have worked on the scorer's and secretary role and also on how to conduct meetings and the last thing I want to work on and that is the treasurer's role and how we go about it in which I hope to iron it out this year to get right.
5. What I have done is gone back over the last 10 years and got the treasurer's reports and compiled them altogether and noticed in 2009 we had a little issue happen where the juniors account was added twice. It is added into the total for the end of year total and in the following year on the running sheet at the start of the year in the opening balance the juniors money was included in that opening balance, but at the end of the year in 2009 it was added again to the total balance, it has always been kept separate after the running sheet. I only picked this up late last year so that \$13,043.57 on the opening balance is correct but in our treasurer's reports in our committee meeting it is incorrect, it has \$3,188.76 too much and in fact this has been the case for the last 3 years for all our committee meeting treasurer reports. I have corrected that but what we are going to do is we will look at the balance in the bank at the end of the year as well and not just on the books because over the years little bits of differences have added up to \$843.91 difference. So to fix all that the best thing for the treasurer to do is to look at the bank account on January first and go off that as that's the true figure for an opening balance. The problem we do have with our bank account is that we have the summer competition money in there as well and that throws us out. Summer competition is a zero start and a zero finish but the problem is come January 1st we still have summer competition money in there. I would really like to have a separate summer and a winter competition accounts and I would like to discuss with Wayne Taylor (Turkanators) about that, and if we can do that legally we will do it. We have taken out the junior's money and put it on an interest account back in September so that will stop that from being doubled up. So this year we will keep an eye on how we do our reports and transactions so that we can be more reliable and accurate in our reports. It's amazing how little things here and there add up, I noticed this when I did the scoring years ago with frames, it was easy to miss a frame and add an extra one here or there. I just wanted to bring it all to you so you know exactly what's going on, so at the moment we have \$16,770.85 in the bank as of the 1st of January 2012.
6. It was then asked if there was any business arising from the report and the President Andrew O'Neill said that just as a reminder that this part of the annual general meeting is about discussing last year's finances, we will discuss next year and what we can do in a few steps time after we have elections for the new committee, then they will decide what to do, not this old committee.
7. Sponsorship there is a sheet there for that showing all the sponsors and how much they have sponsored and who has paid and who has not in the green and red. Treasurer Rosa Payne noted that Barry Plant Real Estate has just paid. A couple have paid twice which will go towards this year's sponsorship. We had an issue with descriptions on deposited cheques couldn't work out who they were. Noted again that Turks Sports Bar is our biggest sponsor and a big thank you to Duane Morrell and Traralgon Taxis another big one too, thanks to all our sponsors and just noting also Gippsland Locksmith's who sponsored our scorebooks over the summer competition as well. Just remember with sponsors they want bang for their buck, times are tougher out there Publicity Officer Rick Merlo will find it harder this time to get sponsorship again. So when you do use them tell them you're from the association so they know. Lawrence & Hanson Electrical

probably won't pay as it's a big hassle for him to get a cheque out of head office, though if we ever run a raffle he would be happy to donate something towards that. We now have all the rest of our sponsors paid up so that good as the other year we were about a \$1,000.00 short. When you look at that sponsorship of \$3,000.00 and \$1,000.00 of that at least is sponsorship for trophies and about another \$1,000.00 is for the handbook printing and binding cost. So we end up with probably under a \$1,000.00 injected in to our bank account, so just understand how important that sponsorship is. So if you don't use it we loss it, Rick and I can't emphasise this enough.

8. The next couple of pages are to do with debts. Theo Luangxayanthone \$10.00 debt was paid by Ted Norton and also Ash Jenkins has paid his fines also of \$57.00.

9. Again any business arising?

Steve Wilson (Crown Cougars) asked about auditing and do we do it ourselves?

The President Andrew O'Neill said that we basically we audit ourselves and have as far as I know; I don't think we have ever done an audit. To audit ourselves ever year the cost is going to be a big factor. We will look into it though and see what we can do.

Vice President Wayne Taylor said that there's nothing in our constitution that says we have to audit but it's probably a good idea.

The President Andrew O'Neill said that we will look into the cost and bring it to the committee for them to decide; remembering that the whole point of this meeting is to get the new committee up and then they run the league from there.

Allan Greenwood (Morwell R.S.L. Greens) enquired about moving a motion to get the books audited every year for the members.

Vice President Wayne Taylor said that the cost could be as high as \$1000.00.

The President Andrew O'Neill again said that Steve Wilson's idea is a good idea and that we will look into the cost and bring that back to the committee of management to decide.

It was also noted that Tom Gill (Turks Bar) is an accountant and maybe he could do it.

1. President Andrew O'Neill said that we have 24 teams this year with 15 nominated for division 2 and 9 teams nominated for division 1. President Andrew O'Neill said that this is something we are going to have to think about because you're going to have about 5 minutes to do that because we still stuck in part c of the annual general meeting and I want to move into part d.

• **Ordinary Business:**

Constitution Rule 11. Annual/Special General Meetings (4) (d) *to receive and consider the financial statements in accordance with section 30(3) of the Act;*

1. President Andrew O'Neill said that in this part of the annual general meeting we will considered what we are going to do over the next 12 months with the business as with the money side of things and that would include fees ect.
2. With 24 teams depending what we do wether we go 2 or 3 divisions, if we go 3 division there will be more cost on trophies but that should be ok we should still be able to cover that with the amount of teams we have this year. We don't make much on registrations it's really the match fees where we make our money. So if anything were to go up it would be the match fees. Although I do not feel the need to raise that at present with 24 teams we should have ampules.
3. Pool Victoria registrations is still the same we have had no correspondence telling us any different.

Rosa Payne (Morwell Golf Club) said that it has not changed.

4. Allan Greenwood (Morwell R.S.L. Greens) said that years ago we raised the fees by \$0.50 and at the end of the day we went forward so what's \$0.50 to every player, I would like to move a motion to raise the match fees to \$5.50 (\$27.50 team). Did not get a lot of support for this.

Wayne Taylor (G.J.H. Blacks) said that yes your right it should edge up all the time but remember we did jump pretty quickly from \$3.00 to \$5.00 so we've probably got a few years covered were we did have the increments but just did it all at once.

Publicity Officer Rick Merlo said but at the end of the day we did run at a profit last year didn't we?

President Andrew O'Neill said that we only just did.

Steve Bishop (Morwell R.S.L. Blues) said that we always stand there and drink and we don't mind paying an extra \$1.00 for a beer in a club or whatever, so what's an extra \$1.00? Quite a few disagreed with this.

President Andrew O'Neill said that if we're going to raise the fees we are better off sticking to round figures so make it \$6.00. But as Wayne Taylor said we probably don't need to raise the fees and I don't think we need to either.

Wayne Taylor (G.J.H. Blacks) said that from a captain's point of view too, if everyone's paying \$5.00 it's a no brainer and from a treasurer's point of view if they've coming in with bags of coins it makes it a hell of a job.

Rosa Payne (Morwell Golf Club) agreed with this, I don't like coins.

Allan Greenwood (Morwell R.S.L. Greens) said Rosa we made money didn't we?

Damien O'Brien (Morwell Golf Club) said that we just played summer and that was \$2.50!

Rosa Payne (Morwell Golf Club) said and that was pain in the a*#*e. (swearing again!)

Ross Kenney (Lenny's Lads) said that Allan Greenwood is part of the committee now so could get him to move up the front so we can actually hear what he's saying.

Vice President Allan Greenwood moved to the executive table up the front.

Alf Shingles (Morwell R.S.L. Allsorts) said we are discussing fees and the fees that where paying at the moment were without selling raffle tickets. Maybe we should organise selling raffle tickets?

President Andrew O'Neill said our biggest problem with raffle tickets is no one wants to sell tickets; it's been a huge problem. And that's probably more the reason why the fees went up to cover the raffle.

Alf Shingles (Morwell R.S.L. Allsorts) said stay where we are if where not selling raffle tickets and down if were selling raffle tickets.

President Andrew O'Neill said I don't think anyone wants to go back to selling raffle tickets and drop the fees; they'd rather pay an extra \$2.00 a week, or even raise the fees.

President Andrew O'Neill said that he is over all this talk; there has been enough talk I'm going to put this up now.

6. President Andrew O'Neill said we have to look at other expenses for the year. The name for the web site payment we made last is that just a one off payment for 2 years so we don't have to pay that this year, is that right Wayne?

Wayne Van Heerewaarden (Sports Bar) said yes it's for 2 years.

President Andrew O'Neill said there are some ongoing issues and cost with that, that we need to discuss here because that's going to be ongoing. We have had the web site up one year now and we are still developing it, we are having issues but we are working through it, there are a lot more things we want to get happening with that web site. But one thing we need to start doing is paying the person who is doing the role and spending a lot of time doing it. He spends a lot of hours on this, he runs a business it's not a free service. I consider this web site the most important thing for the league going forward for the future because everyone is using their iPhones/iPads and computers now; it's the best way we can get information out there now from meetings, to scores everything and it certainly creates a lot less paper work here. But also the fact is that you can just jump on their anytime and access league information all at one central place. How many hours over the last 12 months would you have spent on this?

Wayne Van Heerewaarden (Sports Bar) said well over a 100 hrs.

It's still being worked on its going to take a few more years to get it right. I'll ask Wayne to come up here and talk about where we are going with this and what the general cost are and then we will put this forward towards this association and we will decide where to go from there.

Brad Smith (Morwell Golf Club Swingers) said that he would like to move a motion that this association approach the web provided to negotiate a fee of \$1000.00 remuneration for the next 12 months to be reviewed in 12 months' time.

President Andrew O'Neill said that Wayne van Heerewaarden runs bisonline he's the one who's running our web site, so maybe he should get up here and say a few things first and then maybe he could put an idea forward with what he thinks is reasonable and then we will discuss that and move on from there. So I will ask Wayne to come up here as this association needs to be informed with what it's doing and where it's going and what it's actually getting for what it might be paying for. So I will ask Brad Smith to hold off on that motion if he could.

Brad Smith (Morwell Golf Club Swingers) said that he would rescind the motion.

Wayne Van Heerewaarden (Sports Bar) said basically where it's heading to is I'm currently working on a full mobile site, obviously there's a lot of people about using phones and it's going to make it a lot easier for the finger friendly people, you won't have to zoom in, it's going to have less overall information but the information that will be there for the mobile site will be a lot more effective and easier to use and then there will be the option to go out to the full site on your phone still. Another thing that will happen is it will be a lot more dynamic updating information so for example I'm working on a system at the moment whereas the scores come in I'm going to be able to put them straight into the web site and then dynamically it does everything it will automatically update the scores and ladder, it will know the draw the whole bit, it will just work. So what I 'am working towards is getting it to a point where any monkey could come along in the end and put any information in there update anything and do it from anywhere. You won't be tied to one pc you can be on any computer or even mobile phone on the night, scores can go in done easy. So one thing I 'am moving towards for hopefully towards next year will be that people can actually get in there and actually put their scores in on the night if they want to or if not just text them or ring them through as per normal, sort of taking away the manual part of it that's the goal at least anyway. There will be an online form then it will be just a matter of getting in there and putting the numbers in, there will be a standard log in for members that will be checked regally to make sure they are correct and if there not I can go in and adjust them anyway.

President Andrew O'Neill said that there's other stuff to go on there where trying to put all our results up there from previous years and all the minutes from the meetings to go up there which you will have a basic login in for that. When I finally get the sack from this job I'm going to sit down with Wayne for a few hours and go through stuff with him like that. You can easily go back and look at the last meeting or from whenever, there's a stock pile here of the minutes.

Wayne Van Heerewaarden (Sports Bar) said there's going to be a member's login area that I 'am working on at the moment where all those minutes and stuff where they don't need to be public domain but all the members need to be able to access them obviously if they want too. Putting them in the public domain well there's treasury information that we really don't want the general public to see, it's not there business. So basically every member will have a password which will be changed on a yearly basis or even as we see fit as the case maybe and that way any member can log in if they have a query on a meeting they can go and check it.

Wayne Taylor (G.J.H. Blacks) asked what sort of estimated time that this will be up and running and also a quote for how much it cost?

Wayne Van Heerewaarden (Sports Bar) said basically what I was thinking of and I've been talking to Andrew about it and that is a \$50.00 per month on going fee in which I will continue doing it and developing it over time.

Publicity Officer Rick Merlo said as the promotion officer can I get you to sponsor that towards the league???

Rosa Payne (Morwell Golf Club) said that she was happy to support Wayne as he sponsors the league.

Brad Smith (Morwell Golf Club Swingers) said that over the course of the next 12 months how much of your resources ie how many hours for what remunerations you've just said \$50.00 a month (\$600.00 annually).

Wayne Van Heerewaarden (Sports Bar) said there are still hundreds of hours left in it.

Brad Smith (Morwell Golf Club Swingers) said that you used words like hopefully, will have this and this?

Wayne Van Heerewaarden (Sports Bar) said it's all going to happen but hopefully I'll have it before the start of the season if not the start of next season whatever the case maybe.

Brad Smith (Morwell Golf Club Swingers) said that I think from my point of view and that's a business, you've put up that you're going to cost the association \$600.00 that is a very generous and well worthwhile. So my original motion to pay a \$1,000.00 if we were to put that motion up again will you honour that \$1,000.00 and make every effort to get what we've just talked about done within 12 months?

Wayne Van Heerewaarden (Sports Bar) said absolutely.

Brad Smith (Morwell Golf Club Swingers) said so I will put my original motion that this association invest 1,000.00 for the next 12 months to develop the web site as discussed at the annual general meeting and further to that motion that this motion be reviewed in 12 months' time as to be ongoing.

Rob Irvine (Crown Cougars) spoke against the motion saying that firstly because I want to know cost for hosting the website.

President Andrew O'Neill said that it cost \$308 cost for 2 years for hosting fee and that included the name.

Rob Irvine (Crown Cougars) said that there were other places that could do it for \$90.00 a year with a domain name for around \$20.00 a year and they have excellent hosting. \$300.00 dollars is on the wrong side of that as far as I'm concerned. There are a lot of other people around with hosting fees that are cheaper. Its ok for Wayne or whoever's doing the web site management that's fine but let's gets these fees back down to a realistic value. Wayne Van Heerewaarden (Sports Bar) said that the web hosting is not actually mine I actually do that through someone.

President Andrew O'Neill said that it cost \$308 cost for 2 years, so that's \$150.00 a year.

Rob Irvine (Crown Cougars) said that he still thinks that's too much.

Wayne Taylor (G.J.H. Blacks) said that we are not actually asking Wayne to do this but were asking bisonline to do this, now to actually nail down from like a business point of view what his whole sale cost are and what he is retailing onto us, we are happy with the overall cost and breaking them down and saying we will take this part from you and that part from someone else, I think that the cost being put forward of x amount per year as a bisonline quote for that and just from my business I pay for a site that's about as functional, probably a little bit more but around about the same as what Wayne's offering we pay about \$850.00 per month! To just say we can do it on the cheap and get bits, you go out to mobile and look at developing mine as I say is a little different but if you brought that back to \$250.00 a month to actually have a web site up and running and that is function able and takes data both ways that it takes information in and presents is back out to you, the \$1,000.00 a year that's being suggested is very cheap.

Duane Morrell (Good Old Boys) I would just like to say one thing about this and that is I know where going to back to a meeting that we had a Yallourn North about personal interest involved in making money out of this league and a statement was made that I was making money out of this league and I wasn't even on the executive. I'm not having ago at Wayne I think what he's doing is a great job and I think what he's going to introduce is brilliant but if I'm going to get the shit kicked out of me because some people think that I'm

making money out of this league the league seriously does really well out of our business I'm making it quite clear that Wayne protect yourself because they are going to run at you when they find out your business is making money out of this, they're going to go you big time so be careful. Some people at that meeting about finals and all that and that person is in this room right now and made the statement that I was profiteering out of this league. So watch yourself.

Michael Lubawski (Morwell R.S.L. Allsorts) said that I would just like to say that Wayne put up a price of \$600.00 and if he's happy with that what's the problem.

Constitution Rule 11. Annual/Special General Meetings (4) (e) *to consider other business of which one (1) weeks' notice has been given to the Secretary.*

1. President Andrew O'Neill said to refer to those pamphlets that I handed out. We have to look at By-Laws and then the second thing we will look at is the new world rules as of the 2008 annual general meeting. They have been amended and we have been a bit slow in catching up but I will get to that in a minute.
2. I will do a very quick explanation because most of you won't have an idea what I 'am doing here. Last year I had a number of by-law changes more like alterations making it easier to find things. I was rushed to do it, I did it at the annual general meeting and a lot of stuff got through that were just changes as in moving things round putting headings, changing words to make it a little more legible to read and things, now that got past and as I said I was rushed to do it so what I did straight after the annual general meeting and over the next couple of months was review what I had done, and there were a couple of things I wasn't happy with and that's what I 'am about to raise now.
 - 1) The first and most important thing which is in our By-Laws and what it's to do with is one meeting we have and that's the first summer competition meeting. Originally we used to call it a committee meeting or a sub-committee meeting but you can't really have a sub-committee meeting when you don't have a sub-committee, so what I 'am proposing to do is run it as a general meeting which is similar to this meeting where every member in the association can come along and vote for teams in or member in or out. I want to change this to a general meeting a Summer Competition General Meeting. I can't have it as a sub-committee meeting so in the first 6 pages in a number of areas you will see that I have added special general meeting in green and removed sub-committee meeting in red. See rule 1, 4d, 5, 10, & 12. It's all about making that first summer competition meeting a general meeting that's all I'm doing.

Rob Irvine (Crown Cougars) said are you just asking for the reference to sub-committee to be withdrawn?

President Andrew O'Neill said yes the reference to sub-committee in red is been taking out but I' am alternating how it's been worded. So does everyone understand what I'm doing I don't want anyone coming up to me afterwards.

- 2) There's only one other thing I put on page 6 which is under rule 19 part 5 singles championships part (c), I put in green but on your copy it will be in a light colour to save money as this photocopying cost us a fortune. With preference given for any byes, in other words what that does mean for the singles competition when we go to the 32 draw if there's any byes the preferences are given to the seeded players as in the 4 that were seeded. It was asked of me last year to put that in, I really wanted to make some more changes but I just haven't had time. If there's one bye the winner last year gets the preference or if there are two byes then the runners up last year as well and so on.
- 3) The next section is called the Rules of Competition there's one rule change whilst listening to our December meeting and the banter that went on about forfeits in which no one knew what to do so while listing to that meeting I typed up a forfeiting clause so that we now know what to do and can refer to it. What it does is explain a standard forfeit and a season forfeit and you can see the difference between the two, so if I'm not there then we can just go to the by-laws and there it is written in black and white, it took me all of about 5 minutes to do!!!
- 4) Final Series is the last section in green is what's going in and in red is what's going out. There's no changes all it is just layout. In the first section all I'm doing is laying out the winter finals format for a final 4 and a final 6 and I'm doing the same on the next page for summer competition. It tells you what to do there as there have been a few years where there's been confusion, this now tells you in black and white what to do.
- 5) There is one on the last page and that's Player of the Grand Final which we trailed last year I thought it worked ok so I have put it in as a by-law to say how the player of the grand final is to be selected.
- 6) So unless anyone has any questions I will open the floor and take questions on any of those motion changes more alterations with only the forfeits been the only real addition and also player of the grand final. If there aren't any questions I will now ask for it to be moved and seconded.

President Andrew O'Neill said that you do need to look at the rules. It will be on the web site soon and in the handbook when we get that out. The rules are off the Australian Eight

Ball web site, we had issue with them when I last looked at the rules on the web site and compared them to the rules in the downloadable pdf file, and they conflicted. That's why we haven't gone forward, and at the moment there got the one set of rules up so the rules up there now look alright to me. So I will ask for us to move to the new Australian Eight Ball rule and for that to be move.

Steve Gray (Turks Bar) said that there only little grey areas.

1. President Andrew O'Neill said just a quick word for those with summer competition trophies to get them in so we can finish off the summer competition account. I've seen Tom Gill I just need to catch up with Duane Morrell.
2. President Andrew O'Neill said we need to now look at a start date and therefore we need to look at what we are going to do in regards to divisions. We have 24 teams with 15 in division 2 and only 9 in division 1. There is plenty of room for a middle division it's been there for a while, so I'll open the floor for discussion.

Steve Bishop (Morwell R.S.L. Blues) said 12 x 12.

Neil Stuckey (Destructables) said that he would like to see 3 divisions.

Steve Halliday (Turks Shooters) said that in the By-Laws it says that you can only have 2 divisions unless there are 18 teams or more per division then you can create a third one.

That's in **By-Laws 6. Number of Teams (b)**.

President Andrew O'Neill read the by-law and then agreed with Steve Halliday on the rule and said that I didn't see that, so we are stuck with 2.

Steve Gray (Turks Bar) said hold on a minute isn't this is an annual general meeting where we can change things.

President Andrew O'Neill said no you need to submit a change before the annual general meeting.

Duane Morrell (Good Old Boys) said well what happens if you get one more side?

President Andrew O'Neill said if we have 25 sides we will have to reject one. They used to do this year's ago too and say look come back next year.

Duane Morrell (Good Old Boys) said that's bad for the league.

President Andrew O'Neill said that's why with summer competition I didn't want to reject the teams and I got caught out on it.

Duane Morrell (Good Old Boys) said yes I know and I totally understand where you're at and you got caned for it.

Don McIvor (Morwell R.S.L. Blues) said that we split our team 3 ways to stop a bye in the summer competition and that crucified us in the end.

President Andrew O'Neill said look I know where Wayne Taylor is heading with this so I will read out **By-Law rule 4. Amendments**. Rule was read out.

We really can't do it Wayne we are stuck unless we call a special committee meeting as we don't have the full committee here now.

President Andrew O'Neill said I agree with you there Steve I like the idea of going for 3 divisions, I think it's better. But as the rule book says as Steve Halliday pointed out we have to have 18 teams in each division first before we can create another division. I'll read out the by-law again. So basically if you want to call a committee of management meeting which would be then held in 7 days' time that's next Tuesday and I'm tipping it will be at Turks Sports Bar as that's central for all and to get that past at that meeting it would have to be by 75%.

Allan Greenwood (Morwell R.S.L. Greens) said that he like the idea of 3 division and said that he is all for it. It's no good if teams are getting thrashed week to week.

Mick Lubawski (Morwell R.S.L. Allsorts) said that it's 15 and 9 the difference for 2 divisions being 3 teams so to get your answer tonight who are the 3 teams that have submitted their side tonight who would like to go up to 1st division. There were none.

Duane Morrell (Good Old Boys) asked about the setup of the committee in relation to a general meeting and to the meeting next week about who can vote.

President Andrew O'Neill said that this meeting is all about getting the committee of management up and running for the new season and once that's done, they, the committee of management run the league. And if we decide to have that meeting I will close this meeting rather quickly as there will be no need to keep this meeting open.

Wayne Van Heerewaarden (Sports Bar) said that there a few more things to take into consideration like finals with extra tables.

President Andrew O'Neill said there will be more tables being used and also extra trophies needed and things like that, there will be more costs.

Allan Greenwood (Morwell R.S.L. Greens) said and yes more people playing good.

Rob Irvine (Crown Cougars) said that back in the 2000 annual general meeting it was decided because the Olympics were coming and we were going to finish our season early, and that if you have any more than 22 rounds then you would have 2 divisions and that was when the summer competition first came in, apart from that we don't really need this summer competition and this only is my option but if you've got less than 22 rounds you have 1 division that's what we decided at that meeting now, I don't recall at any annual general meeting after that it being changed to 18 rounds or anything like that.

President Andrew O'Neill said that the rule here says 18 even know that may have been the case back then but we go by this book.

Rob Irvine (Crown Cougars) said that relegation was also decided back then with it been split down the middle and that was that no argument. It was also decided at a meeting around at Arthurs place (Xscape) that if any new teams entered that they would automatically be introduced to division 1 to stop any new team forming with new players from Melbourne.

President Andrew O'Neill said they have to live within the locality of the Latrobe Valley anyway but also the executive decide in the end who goes up and who does not, they have the power to override any of that.

Don McIvor (Morwell R.S.L. Blues) said I spoke to you and you know I spoke to you we were going to take 5 teams out of the RSL this year and it was going to be too hard with 2 divisions, now were talking about 3 divisions.

President Andrew O'Neill said that you still have 2 tables with 4 teams so 2 are at home every week and two are away. It's possible to do a draw with 5 teams and 4 tables but other teams will have to be away when they would have otherwise been at home so it's not fair on them.

Wayne Taylor (G.J.H. Blacks) said I'd like to put forward a motion (again) that the executive put together a motion to change the rule that Steve brought up or any other rule to effectively allow us to go to 3 divisions.

This Special Committee Meeting has been called by the President Andrew O'Neill after a motion was moved and accepted at the Annual General Meeting in accordance with **By-Law 3.**

Amendments.

1. Motions.

1. Annual General Meeting motion.

To hold a Committee Meeting in 7 days' time and for the executive to get a motion forward to the effect to change **By-Law 6. Number of Teams** or any other rule that will allow for 3 divisions to be created for the 2012 Winter Season.

Moved: Wayne Taylor (Turks Magpies)

Seconded: Aaron Omera (Turks Shooters)

Carried

2. Committee of Management motion.

As required by **By-Law 3. Amendments**, the members of the Latrobe Valley Eight Ball Association at the Crown Hotel on the 27th March, 2012 at Annual General Meeting have voted in favour of asking for the Committee of Management to consider the wavering of **By-Law 6. Number of Teams** to allow for 3 divisions to be created for winter competition season 2012.

The Committee of Management will also at this meeting make ready the season to get under way and will make decisions necessary to achieve this outcome.

2. Information regarding the motion.

1. Divisions: President Andrew O'Neill advised the decision to be made at this meeting is to stick with a 2 division competition for winter 2012 or change to 3 divisions. If we did stick with 2 divisions this would mean 12 teams in each division, however if the decision was to go to 3 divisions the arrangement would likely be 9 teams in division 1, 8 teams in division 2 and 8 in division 3 as there is another team who would like to join into the competition this winter season (Average Joes) which now makes 25 teams.

President Andrew O'Neill informed the committee will need to change/amend the bylaw at the next annual general meeting if this structure was to continue past the winter 2012 season. He informed the main drive to consider this change to 3 divisions is some of the teams in division 2, in that there are some very strong teams in division 2 that are not quite strong enough for division 1 but too strong for some of the lower teams in division 2. There are 9 teams that have nominated for division 1; they will stay in division 1 if the outcome is to go to 3 divisions.

2. Income: President Andrew O'Neill advised there would not be as much money generated for the season with 3 divisions as there are less weeks played in the season, this is something that needs to be considered. The Executive have not yet decided the breakdown of divisions 2 and 3, if that is the decision that is made.

3. Voting: Shane Vogt (G.J.H. Blacks) queried who can vote, President Andrew O'Neill clarified the 2 representatives from each team and the Executive are the Committee of Management and can vote, however other members and the visitors cannot vote.

3. Comments from team representatives.

President Andrew O'Neill opened the floor for comments from team representatives.

1. Steve Gray (Turk's Bar) advised he is for the motion, as it would be good for the league and to improve player's skills. To cut costs Steve Gray informed he is also quite happy for there to be no trophies for runners up to save costs this season.

2. Don McIvor (MRSL Reds) advised he is for the motion, and expressed concerned that if there were only 2 divisions, some of the lower teams in division 2 may forfeit and drop out as this has happened before.

3. Guy Galea (Destructabulls) advised he is for the motion, queried if this was an ongoing arrangement would the top 2 teams and bottom 2 teams in each division move up and down in division like they have in the past. President Andrew O'Neill clarified this is a rule that still applies and will continue this way, we may need to change the bylaw at the next annual general meeting in relation to this depending on what structure is going to be put in place at that time.

4. Tim Dale (Top Pub Elites) advised he is for the motion, stated it is good to see a women's team finally come into the league, and the 3 divisions will make it easier for younger teams to come into the league.

5. Publicity Officer Rick Merlo (Top Pub Smashers) advised he is for the motion, as this structure may encourage more players and more teams to come into the league.
6. Vice President Allan Greenwood (MRSL Greens) advised he is also for the motion, as it will be good for new players to start in division 3 and have the opportunity to move up to division 2.

President Andrew O'Neill asked if there were any members against the motion.

7. Scorer Wayne Van Heerawarden (Sports Bar) advised he is not sure at this stage if he is for or against the motion as he has some questions, he asked about the costs involved in 3 divisions as opposed to 2. Will the 3 division structure create a logistical issue for those venues where for eg Morwell RSL have 2 tables and 4 teams? President Andrew O'Neill advised the system currently in place for developing the draw would be used to try to make it as fair as possible for all teams as the goal is always to have an equal amount of home and away games in the season. This has not always been possible however this will be what he will work towards. Scorer Wayne Van Heerawarden raised concerns that if this does not work out evenly this may then benefit some teams or disadvantage others. President Andrew O'Neill advised this is the only way forward, and if the current method of developing the draw does not work out we may need to contact Andrea Bird from Pool Victoria to use their automated system.

4. Costs/Budget.

1. Costs: Regarding initial costs, President Andrew O'Neill advised these costs will be trophies, an extra table to hire for the finals, and there are other bills that will need to be considered, webpage cost for eg is \$600 per year. The main income during the season is match fees which President Andrew O'Neill does not want to increase, sponsorship covers the cost of the rule book and trophies etc, and is lucky to bring \$1000 into the league. There will also be a cost for Steve Gray to go to the Nationals which he does every year. The cost for this will be \$1000 this year; \$500 more as Steve Gray has not claimed last year's yet, so there is a lot to consider and the Executive need to budget to ensure the league at least breaks even. Steve Gray (Turks Bar) made the point that this is a trial this year and if it did cost the league a little bit extra then we would make adjustments for next year.

David Rash (Good Old Boys) advised that he is for the motion and asked about the season length, are we aiming to play each team twice and if so our cost would be minimal or nearly exactly the same. President Andrew O'Neill referred to the 2nd and 3rd divisions not playing as many rounds as the 1st division because of the amount of teams in those divisions. If we made a supplementary draw so the 2nd and 3rd divisions played the same amount of rounds as the 1st division then that would increase the income and hopefully assist to break even with the budget for the year. It was raised that trophies are the biggest cost to the league; President Andrew O'Neill advised the Executive will do the costing and work out what the trophies will be given and for whom.

2. Budget: President Andrew O'Neill advised the amount of rounds played will affect the amount of income that comes in during the season, last year match fees brought in \$8,000 and registrations \$600. If each team only plays twice against each team in their division, the match fees will only come to \$9,200, we need to look for more than that to cover the costs for the season.

5. Winter Season 2012.

1. Divisions: President Andrew O'Neill asked for a motion to go ahead with 3 divisions (see motion point 5. Special Business, 1. Motions, 2. Committee of Management):

Moved – Rick Merlo (Top Pub Smashers)

Seconded – Don McIvor (MRSL Reds)

Carried unanimously

Neil Stuckey (Destructabulls) asked rather than call them 1st, 2nd & 3rd divisions can we call them an open for the 1st division and then a 1st & 2nd division. President Andrew O'Neill advised this can't happen as anyone can come into the competition if it is called an open division.

2. Division Structure: President Andrew O'Neill then read out a rough structure of the teams in each division and advised the exact structure will be decided by the Executive and there may be some changes to what he has proposed. If any team has an issue where I have proposed to put them please see me after the meeting.
3. Number of Rounds: President Andrew O'Neill put forward an idea that each division plays 18 rounds and included a supplementary draw for division 2 and 3, where the first 4 rounds might be tacked onto the end of the draw to make up the 18 rounds. This would be a blind draw and may work for some but not others ie you may play a "top team" for a third time or a "bottom team". This would bring in more money for the season and hopefully cover costs.

President Andrew O'Neill asked for the motion to be put forward for this proposal to allow for 18 rounds:

- b.** Summer Competition. President Andrew O'Neill informed the summer comp finances have been finalized bar the money left over which we voted to send on to Andrew Allen's family. 5. Singles Competition for 2nd & 3rd division.

President Andrew O'Neill advised this competition needs to be organized very soon, and suggested it occur either this weekend or the weekend after. It was suggested not to hold it this coming weekend as it is a long weekend. It was proposed the competition be held on Sunday June 17 at Turk's Bar. All teams need to inform their members about the competition, and if they want to compete they need to be at Turk's Bar at 9:30am on June 17, so the competition can start by 10-10:30am. - Don McIvor (MRSL Reds) obtained a basic written quote from the Morwell RSL including a \$18 per head for smorgasbord menu and a \$20 per head for table service menu, with drinks at members prices starting at \$3.20 for a pot of heavy;
- President Andrew O'Neill (Sports Bar) informed the Traralgon Bowls Club will be doing some major renovations so aren't able to offer their venue;
- Andrew obtained a detailed written quote from the Premier Function Centre including a \$26.50 menu option, a \$31 menu option and a \$35 menu option, with drinks starting at \$4.20 for a pot of heavy.

Andrew handed out the written quotes to each table. It was felt that the Traralgon Vineyard quote was too expensive, so the discussion centered around the quotes from the Morwell RSL and the Premier Function Centre. President Andrew O'Neill stated there is quite a difference in the quality of food between the two options, he recently attended a function at the Premier function Centre and the food was of a very high quality, the presentation of the center itself was very nice as well and he would recommend this option as they put on a good night. Andrew stated that if we are looking at lifting the quality of the function then the Premier Function Centre would be good.

Andrew also informed if the function is held at the RSL, people would put down a \$20 deposit and this amount would be refunded on the night, whereas if the function is held at the Premier Function Centre, there would have to be a different arrangement eg people would need to put down a \$35 deposit and \$20 would be refunded on the night, so there is a difference in cost to each individual as well as the Association.

Andrew opened the floor for discussion:

- Numbers were discussed, Andrew stated he is expecting hopefully more than 150 people to attend, in previous years we've had around 120-130;

- Don McIvor (MRSL Reds) stated there is quite a difference in price between the two venues which he doesn't mind but earlier we were quibbling over hiring tables for finals but there's a big difference between the meal prices;
- Life members don't pay for their meals as per usual;
- Treasurer Mick Lubawski (MRSL Allsorts) stated the way it works out, if we go to the Premier Function Centre people will pay in the end \$15 for their meal whereas at the Morwell RSL they won't pay anything;
- Andrew stated members **must play a minimum of 5 games in the season** to qualify for the subsidized meal;
- Partners will have to pay full price with no subsidy;
- Last year a pot of beer was capped at \$3.00 however prices have gone up since then so it won't be the same;
- Last year the Association spent \$2,000.00 on alcohol subsidy, Andrew stated he would like to see the subsidy reduced or even scrapped.

Andrew asked for a show of hands for who votes for the Presentation Ball to be at the Morwell RSL.

1st Executive Meeting of the Latrobe Valley Eight Ball Association held at the office of BizOnline – First floor, Suite 1, 7-13 Post Office Place Traralgon on 5th September 2012 at 5:00pm.

- **Business:**

- 1. Sponsors attendance at the Annual Presentation Ball.**

Some teams have asked if their sponsors can attend the Annual Presentation Ball. This was discussed at the last committee meeting however was not ratified. The issue is that sponsors will benefit from the cost of the meals and the subsidised drinks at the cost of the Association, which takes away from the benefit of sponsorship.

Paul Pike has made a request for exemption for a friend of his and his partner who would like to come to our Annual Presentation Ball. Paul Pike said that he is representing Victoria alongside himself in the nationals this year. He said that he doesn't drink either so there wouldn't be a cost to the league.

Decision – Discussed by executive in relation to point 2 and it was decided unanimously that this request be denied.

- 4. Pool Victoria.**

5. Protest lodged by Turks Shooters.

Regarding Danny McLean a member of the Morwell RSL Allsorts not wearing appropriate footwear during the semi-final played on 4th September 2012. Executive referred to **By-Laws – Final Series 7. Dress Code (a)** which states “black or dark slacks or shirt, black or dark dress shoes and a collared shirt. **Jeans or runners are not permitted.**” **Dress Code (c)** states “*any player not dressed in the proper attire will not be permitted to play*”.

The player in question was wearing light tan “casual” type shoes, and therefore was not dressed in the proper attire. This was not picked up until the end of the second frame of the set he was playing and it was brought to the attention of the Captains of both teams competing.

The difficulty with this issue is that it doesn’t state in the by-laws whose responsibility it is to identify the breach of the dress code, and who is to enforce it. Therefore there was some confusion at the time as to what action to take and so the semi-final was played out. Turks Shooters then lodged a protest in relation to this.

Executive then referred to **By-Laws – Rules of Competition 13. Match Protests** which states “*if a player feels the Umpire has made a mistake on interpretation, or lack of knowledge of the rules, he/she may lodge a protest*”. The by-law referring to dress code does not state it is the responsibility of the Umpire to enforce the dress code, and given the by-law referring to match protests is only in relation to an Umpires mistake, the by-laws do not allow for the Executive to make an informed decision about what action to take in relation to the protest.

Decision – Protest quashed.

It was decided by motion by the executive that for the 2012 finals to enforce the representation of umpires from both participating teams and to leave the decision on the dress code by law to be enforced by both the umpires. The umpire will stop time running and request the player to meet the dress code requirements before they can play there shot, once said the umpire will then re-start time running.

General Business: This Special General Meeting has been called to organise the Summer Competition for the 2012-13 season, and this is the only business to be conducted at this meeting. 1. Introduction.

President Andrew O'Neill welcomed everyone to the Summer Competition General Meeting and advised most teams have submitted their team entries for the Summer Competition except for the Morwell Club Shooters and Yinnar Hotel.

2. Number of Team Entries.

c) Fines: Wayne stated there are a few fines in the last few weeks for teams who have not phoned their scores in on time, they are:

- i. Morwell RSL Reds have received fines for Rounds 8 and 11;
- ii. Top Pub Elites have received a fine for Round 8;
- iii. Good Old Boys have received a fine for Round 7;
- iv. Lenny's Lads have received fines for Rounds 7 and 10.

Wayne stated the fines are \$10 each. Treasurer Mick Lubawski reminded people that teams need to pay their own fines individually, ie the RSL and Top Pub do not pay the team fines, and the fines need to be paid directly to the Association. Wayne advised they would need to be paid before the next round you play as if you have not paid your fines you become "unfinancial". President Andrew O'Neill said the fines have come in because of the ongoing issue of teams not phoning or texting in their scores. Wayne has let this go a few times but if teams do not send in their scores it delays getting the scores on the website and putting it in the local paper. Wayne stated there have been situations where he has had to chase scores from team's right through the week and weekend, this is ordinary.

Wayne Taylor asked if it was an issue if both teams texted their scores through, Scorer Wayne Van Heerewarden stated no this is not an issue, sometimes both teams text through scores and this is not a problem. This does not create any confusion; it just means that if all the scores come through, they can be put on the website the following day.

Andrew asked if all teams that have been fined are still at the meeting, Top Pub Elites and Good Old Boys have left the meeting. Wayne stated the fines are listed on the website underneath the ladder, and the bottom line is if a team turns up to play and they don't know they've got outstanding fines, that's their problem. Neil Stuckey (Destructabulls) stated he believes the team should not be able to play (if they are unfinancial) as it penalizes the opposing team who should get the points. Andrew

stated that is exactly what will happen. Wayne stated if a team turns up to play on a Tuesday night and you know they are unfinancial, it is not your responsibility to make them aware of it, just play the games out as usual.

- d) Morwell Club Shooters/Turks 2nd Coming: President Andrew O'Neill stated at the start of this season we needed an even number of teams in each grouping so he had to chase up some teams. Morwell Shooters informed they were putting a team in and the night before the first round of the season Andrew sent out a text to advise all teams their scorebooks would be waiting at their venues. Andrew then got a text back from Morwell Shooters stating they were not putting a team into Summer Comp. Thanks to Turks 2nd Coming for putting in their team late to cover this spot because the Association would've been in a bit of bother with uneven teams in one grouping, you can't have an uneven number of teams with groupings. Andrew stated it is the height of rudeness for a team to pull out at the last minute when a comp has been organised, and only in response to a text from Andrew. Andrew asked that if a team decides to jump out or skip winter or summer comp, please give plenty of notice and then we won't jump down your throat.

3. Finals Venue.

President Andrew O'Neill advised the Turks Sports Bar is the only venue that have put their hand up to hold the finals, asked if there are any other venues that would be interested in holding the finals? Given there are no other venues offered this does not need to be voted on, the finals will be held at the Turks Sports Bar.

4. Catering.

Andrew stated the catering will be done the same as last year, will be offsite catering with a bbq as well, there was good food and plenty to go around last year. Andrew asked if there were any issues with that or any other suggestions. Shane Vogt stated the prawns were frozen, Andrew stated he would pass that information on to Duane.

Andrew stated there is extra money this Summer Comp due to charging \$4 instead of \$3.50, maybe we should have cut rego's back to \$1 instead of \$2. Mick Lubawski suggested if there is more money then maybe extra money could be put into the drinks to lower the drink prices. Andrew suggested this can be finalized at the next meeting, and we need to ensure there is some cheaper drinks left for the finalists.

5. Finals Format.

President Andrew O'Neill stated there are two proposals being put forward that we need to vote on tonight to decide the structure of the Summer Comp finals.

- a) Wayne Van Heerewaarden's idea – to hold a Major final and a Minor final. This means the top 2 teams from each group will go through to the major final, which will be played out as a final 6, like we usually do so there will be nothing different there. The order of the final 6 will be decided upon firstly based on their position on the ladder in their grouping, the points they've accumulated, and thirdly by their %. All games are to be played on the same table unless agreed by both team captains and are to be played on net pocket tables only.

The minor final would be very similar in the sense that it will be the top 2 from each grouping of Division 2 and 3 teams only that goes through to the minor final. Teams qualify to be part of the minor final based on the following criteria – they did not play in Division 1 in the previous Winter Competition; they did not play in the previous Winter Competition's Grand Final for Division 2; and if a Division 2 team qualifies for the major final, then they will not be eligible for the minor final. The minor final will use the same final 6 system, and the order will be determined in the same way as the major final.

Wayne Taylor (Turks Magpies) suggested 2 out of the 3 teams get a double chance in the finals, Wayne Van Heerewaarden stated the first two teams don't play the first round of the final 6, so there is not double chance. Wayne Taylor raised that the top 2 teams have one less round to play to get to the grand final, and suggested this is a disadvantage to them.

Steve Halliday (Turks Shooters) argued all of this should have been decided at the start of the season, we are now in round 11. President Andrew O'Neill stated that when we had our first meeting we didn't know how many teams we were going to have and what format we were going to have either, groupings or divisions. Andrew stated in future we should have an even number of groupings with a shorter season; this would have made it a lot easier to sort out the finals. Steve Halliday stated he doesn't disagree with the format at all and thinks it works, the issue is this should have been done earlier.

Andrew stated that earlier we decided that the top 2 teams would go through to the finals and have a minor final as well, how the minor final was going to work we didn't know and said we would decide that at a later date. That's what this meeting is about. Don McIvor (Turk's Breakers) raised the same thing happened last year, no one gave a shit about the Morwell RSL Blues being too high up the ladder when it came to the minor final, Adam Skilbeck (Morwell RSL Uglii's) stated we had to look at losing games to get into the minor final last year. Andrew stated that's why we're looking at this now to avoid issues like tanking, decide on who is eligible for the minor final. Wayne Van Heerewaarden went over the details of his idea again. Adam Skilbeck stated the Morwell RSL Uglii's won't be eligible to play in the minor finals because they played in the Division 2 Grand Final in Winter Comp, even though the team has changed. Wayne stated this is something the Executive could look at.

Wayne Taylor (Turks Magpies) stated he has an issue with having a major and minor divisional finals when we voted not to have divisions. Andrew stated that's not the case, it's major and minor finals not divisional finals because Division 2 teams have the opportunity to play in the major finals and it wouldn't be fair for a Division 1 team to play in the minor finals.

Secretary Claire Blackford asked what the theory is behind teams not being eligible to play in the minor finals if they played in the Division 2 Grand Final of Winter Comp, Wayne Van Heerewaarden stated the theory behind this is those teams are looked at as going up into Division 1 the following winter. Claire stated this theory then makes it

divisional and disadvantages those teams that played in the Grand Final in Division 2. Wayne stated if this is an issue then it can be taken out of this format, Andrew suggested if teams played in Division 2 or 3 in Winter Comp they are eligible for the minor finals and can play in the major finals if they make it, and if teams played in Division 1 in Winter Comp they are eligible for the major finals only. Problem solved.

b) Wayne Taylor's idea – Final 12 finals (top 4 from each group).

Wayne Taylor stated he has been looking at this for some time, you need either 4, 6, 8, or 12 teams for a final, and with 3 groups it needs to be a final 12. This means the top 4 teams from each group would go into the finals. The winning team from each group would be ranked 1st, 2nd, and 3rd based on their matches and points. The remaining 9 teams would be ranked 4th to 12th based on the above also.

The finals would be played as a final 12 system, which is basically like an AFL final 8 system, with an extra round of knockout before that. It makes for a longer day because there's an extra game. The first round consists of only 8 teams, they would be the final teams ranked 5 to 12, and is an instant knockout. The progressers of them go through to the next round, which then becomes like an AFL final 8 system. The only issue he can see is the extra time to play the extra round and some games will need to be played on coin-operated tables however so does the other team. Andrew asked if it would be a blind draw for tables, Wayne Taylor stated absolutely not, the highest ranked teams would get the pocket tables.

The main benefit is that all teams that finish in the top 4 of their group get an even chance in the finals, you just need to win on the day. Wayne Taylor advised that Part B to that, if people wanted to, we could hold a Division 2 and 3 finals, or Tier 2 finals. To be eligible for that you would need to have played in a Division 2 or 3 team in the Winter Comp, and do not currently have a player in your team who played in Division 1 in the Winter Comp, if you have, that's bad luck you can't play in the Tier 2 finals. Also, if you are eligible for the Tier 1 finals, you are ineligible to play in the Tier 2 finals.

Wayne stated the Destructabulls and Morwell RSL Uglie's would be ineligible to play in the Tier 2 finals because they played in the Grand Final of the Winter Comp.

Allan Greenwood stated he would like to put forward a motion that we go with Wayne Taylor's idea, Andrew stated we need to take questions first. Rick Merlo (Top Pub Smashers) stated this format basically ensures that all Division 1 teams get to play in the finals, Wayne Taylor stated not if Division 2 teams get their arses into gear and beat them.

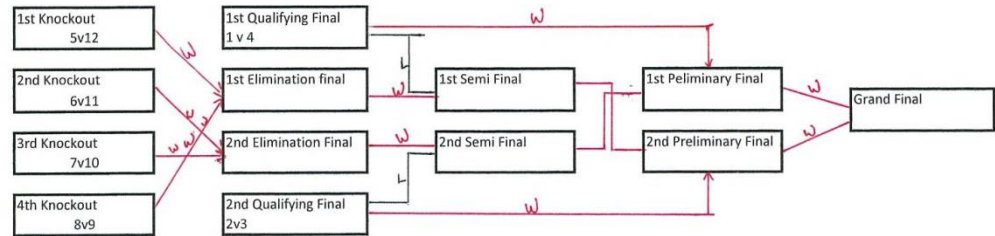

Chris Mayer (Jezza's Turkeys) stated Division 1 teams are not going to bring in new players to break up a team they've put together and are comfortable with.

Mick Lubawski stated there was opportunity at the last meeting to vote for Divisions or groups, everyone voted for groups and it was also voted that the top two teams would go through to the finals, so why is this being discussed now.

Some argument happened regarding divisions and groups.

President Andrew O'Neill stated everyone knows the two different formats so we need to vote now to make a decision, and asked if everyone has a basic idea of the two different formats.

Proposal b) (Wayne Taylor's idea) - 9

Andrew stated there is just an issue with the Rossmore Hotel as they didn't play in the Winter Competition so the Executive will need to decide which finals they are eligible play in.

If you're playing and you're not sure what's happening, ask for a time out and ask your captain. If you're not happy with a markers call, you have the right to ask to stop the game and ask to check the rules, if the marker is not listening ask your captain. The whole team shouldn't be getting involved more often than not half the players are wrong, so refer to the rule book and let the captains sort it out. Everyone has access to the rule books, they're on

the website. Also people are feeling pushed into decisions when they don't feel comfortable with it, stand up for yourself and ask your captain if you need to. Wayne stated if you haven't read the rules yet, read them, its round 11 so everyone should know the rules by now.

26. Yallourn Bowls Club – all good.

27. Yinnar Hotel – gone.

President Andrew O'Neill stated there is an issue with players being late; the start of playing time is 7pm so teams should be ready to play without players consistently showing up late. Summer is fairly relaxed but you should be ready to play by 7pm, its fine when 1 person is late but when you get multiples being late that becomes a real issue. Andrew stated if a player is not there by the end of the first round, they forfeit that game, if the player is not there by the end of the second round, their game is forfeited and if the player is not there by the end of the third round they forfeit that game. The captains of both teams can negotiate to move games back if they choose to but only if both captains agree on it.

Steve Halliday (Turks Shooters) stated there is already a rule in place, if you're not there by the time your game is to be played in the first round you forfeit that game and if you're not there by the time you game is to be played in the second round you forfeit the lot.

Don McIvor stated he is happy with that however you'd be the biggest arsehole under the sun if you did say the frame was to be forfeited because the opposition player wasn't there. Wayne Van Heerwaarden stated there should be no subjective decision making, the rules are there and should be followed.

1st Summer Competition Executive Meeting of the Latrobe Valley Eight Ball Association held at the office of BizOnline – First floor, Suite 1, 7-13 Post Office Place Traralgon on 24th January 2013.

President Andrew O'Neill opened the meeting at 5:20pm.

Business:

1. Clarification regarding certain teams' eligibility for the major or minor finals of the LVEBA Summer Competition, as directed by way of motion at the previous Sub Committee Meeting.

The decision by way of motion at the 1st Sub Committee Meeting, held at the Rossmore Hotel on 19th December, was that all teams who played in Division 2 and 3 in the Winter Competition, are eligible to play in the minor finals in the current Summer Competition, and the major finals if they make it; all teams who played in Division 1 in the Winter Competition are eligible for the major finals only. The motion included a requirement of the Executive to decide on particular teams' eligibility for either finals. The two teams in question are the Yallourn North Bombers and Yallourn Bowling Club.

Decision – The Executive made a decision by way of vote that the Yallourn North Bombers are eligible to play in the major finals only in this Summer Competition, and the Yallourn Bowling Club are eligible to play in either finals.

2. Query regarding By-Law 11. Emergency Players.

This issue has come about due to some players being an emergency player for some teams and whether they are in violation of this By-Law when they have then played as an emergency player for another team. The **By-Law 11. Emergency Players (a)** states: "They do not have to meet clearance requirements to change teams for the first three (3) games they play for any team." This By-Law has been misunderstood by some players who have read this as any particular team, whereas its meaning is any one (1) team.

Decision – This clarification will be changed in the By-Laws at the AGM to reflect it's meaning of any one (1) team; no player is in violation of the By-Laws.

3. Dress Code – role of the Head Adjudicator.

It was decided by way of motion at the Executive Meeting on September 5, 2012 that it is the role of the Umpires to identify a breach of the **By-Laws – Final Series 7. Dress Code (a)** which states “black or dark slacks or shirt, black or dark dress shoes and a collared shirt. **Jeans or runners are not permitted.**” and **Dress Code (c)** which states “*any player not dressed in the proper attire will not be permitted to play*”. The motion states “the dress code By-Law to be enforced by both the Umpires. The Umpire will stop time running and request the player to meet the dress code requirements before they can play there shot, once said the Umpire will then restart time running.”

Some discussion occurred about the necessity for the Head Adjudicator to play a role in this situation to put pressure on the Umpires to ensure the dress code By-Law is followed and enforced.

Decision – if an Umpire does not pick up on a breach of the dress code By-Law and the Head Adjudicator is called in, if the Head Adjudicator confirms there is a breach of the dress code, this will result in an immediate loss of frame for the player who is found to be in breach.

- a) The bank statement was discussed (see below).
- b) Monies owed. Treasurer Mick Lubawski advised all money should be handed in tonight so the Association knows where we're at financially on Sunday for the finals, Turk's Magpies still owe \$120 and Lenny's Lads still owe \$170. 5. Secretary's Report.

President Andrew O'Neill decided the Executive should have a quick meeting to make this decision as there seems to be a lot of stuffing around and people acting like idiots. Aaron O'Mara (Turk's Shooters) stated the finals can't start too early because the table leveling takes about 2 hours and he can't start earlier than 8:30am.

The Executive discussed the issue and decided that because of the time needed for Aaron O'Mara and Shane Vogt to do the table leveling the practice will start at 10am and the final's games will start at 10:30am.

The Sub Committee Meeting resumed, Andrew informed everyone the decision has been made that practice will start at 10am and the final's games will start at 10:30am.

Wayne Van Heerewaarden read out the practice times for each team in the finals, as follows:

1) Major finals

10am – Morwell RSL Allsorts and Sports Bar to practice

10:15am – Turk's Shooters and Grand Junction Hotel to practice

2) Minor finals

10am – Top Pub Elites and Yallourn Bowls Club to practice

Andrew and Mick Lubawski recommended the teams arrive in time if they are playing in the second round of the finals, the games will be forfeited if players aren't there.

- b) Eligibility. Andrew stated all players need to have played a minimum of 5 games in the season to qualify to play in the finals, as per the **By-Law Final Series 6. Eligibility (a)**, we will be checking to make sure.
- c) Head Adjudicator. Andrew stated we need two Head Adjudicators because Ted Norton who is one of our Head Adjudicators is playing in the finals so we need another. Steve Halliday put his hand up to be the other.
- d) Drink's subsidy. Andrew stated he has discussed the subsidy with Duane Morrell and drinks will be capped at \$4.00, which will cover the cost of a beer, if you drink something that costs more ie spirits, you will pay the extra. The drinks subsidy won't start until lunchtime, and the bar opens at 10am. \$300 will be put aside for the finalists so they can benefit from the subsidy once they have finished playing.
Andrew stated we've had issues in the past with people buying subsidized drinks for their friends or partners so we've decided to use a stamp so the staff at Turk's Bar only give subsidized drinks to those who are eligible and we won't get ripped off again like we have in the past. People will only be able to buy 1 drink at a time, and if you're seen buying drinks for other people who aren't eligible for the subsidy then you will be unable to buy any subsidized drinks from then on so if you get busted don't come crying to me. The subsidy is for the benefit of the eligible members not for the public or anyone else, and we'll have a list of who is eligible and we'll be checking.
- e) Tables. Andrew informed the major finals will be played out the front and the minor finals will be played out the back, and the games will be played on net tables only.
- f) Dress Code. Andrew stated the Committee can decide whether shorts are acceptable as part of the dress code because it's going to be a really hot day on Sunday, but given Win TV is going to be there it's probably important that we stay with long slacks. Some discussion occurred regarding the air conditioning at Turk's Bar, it does get very hot at that venue. Don McIvor (Turk's Breakers) suggested this is the biggest marketing that's happened for the league so we should do it properly with the proper dress code in place.

- 1) **Motion** – the temporary dress code as per Winter Competition finals to remain in place for the Summer Competition finals, ie no variations on black or dark dress shoes or slacks; captains are to ensure their players are dressed in the proper attire before the match; both appointed markers are to enforce the dress code rule.

- l)** Annual General Meeting. Andrew informed of the details of this meeting (Tuesday 5th March at 7pm at the Morwell Golf Club) and encouraged all members to attend. Andrew stated there are entry forms here at this meeting for Winter Comp and all teams need to bring this form completed to the AGM so they can be part of the Winter Comp. Andrew stated it is very important for all members of this league to attend the AGM because there are some Amendments to the By-Laws that will be voted on that night, and some additions to the By-Laws that will be voted on. Andrew stated these amendments are on the website so have a good look at them so you are fully informed before you come to the AGM. Andrew suggested if anyone has any questions or feedback about the amendments to contact him or Wayne and discuss it prior to the AGM so they can make any changes that might improve the amendments.
